Re: Survey for John M. Stone and Mary A. McQuiston

Introduction & Background: On January 18, 2005, the Board of County Commissioners approved a request for a variance from Section 6.2, Rural Roads, D (1), Private Road, (3) [f], regarding road slope and a request for sketch design approval for two (2) subdivision lots.

Discussion & Analysis: As stated above, the Board of County Commissioners approved a variance request to allow a 13% road slope for a distance of approximately 350 feet northward from the location where the Phase I county standard roadway stopped south of the creek. The Subdivision Ordinance currently requires that the road slope for a county standard private road not exceed 10%. The Board also approved the sketch design request for the subdivision of Lot 6-B (15.3 acres) into two lots, Lot 6B1 – 8.144 acres, and Lot 6B2 – 6.719 acres. Conditions of approval included upgrading the roadway in New Hope Trails, Phase II to the county private road standard and upgrading a portion of the Phase I roadway, see attachment # 2.

Per attachment # 3, the required improvements have been made and certified by a licensed surveyor.

Septic improvement permits have been received for Lots 6B1 and 6B2 from the Environmental Health Division of the Chatham County Health Department.

The plat displays the necessary information.
