**Issues for Further Discussion and Analysis:** Attachment # 4, states how the developer is addressing condition # 1 of sketch design approval. Attachment # 5, includes a soils map showing the locations of septic systems / repair areas in relation to the adjacent well. The developer has shown on the preliminary plat the '100 foot well easement'. Staff thinks this should be labeled as '100 foot well setback' on the final plat. The developer has agreed to revise this language on the final plat.
