Introduction / Background / Previous Board Actions:

Sketch design approval is good for six (6) months from the date of Commissioner approval. Sketch design has since expired; therefore, the applicant is requesting sketch and preliminary review at this time.

Issues for Further Discussion and Analysis: A 50 foot wide public right-of-way has been shown on the proposed map between lots 12 & 13 to provide access to the adjoining property of Ruth R. Clark, containing 141 acres. It appears this property has a 30 / 60 foot easement out to Hwy 64.
