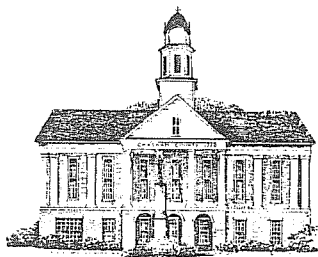

On June 20, 2005, I evaluated the 19 +/- acres for the proposed use of 84 camper sites, a bath house, laundry, and pool. The site appears to have adequate areas of provisionally suitable soils to support this use. Four systems will be permitted at the site to accomodate each phase of expansion. Each system will have three 1500 gallon septic tanks, a 3500 gallon pump tank, and a drainfield utilizing innovative trenches distributed by a pressure manifold.

I trust that this is the information that you require at this time. Improvement Permits will be issued soon. If I can be of any further assistance, please call.
