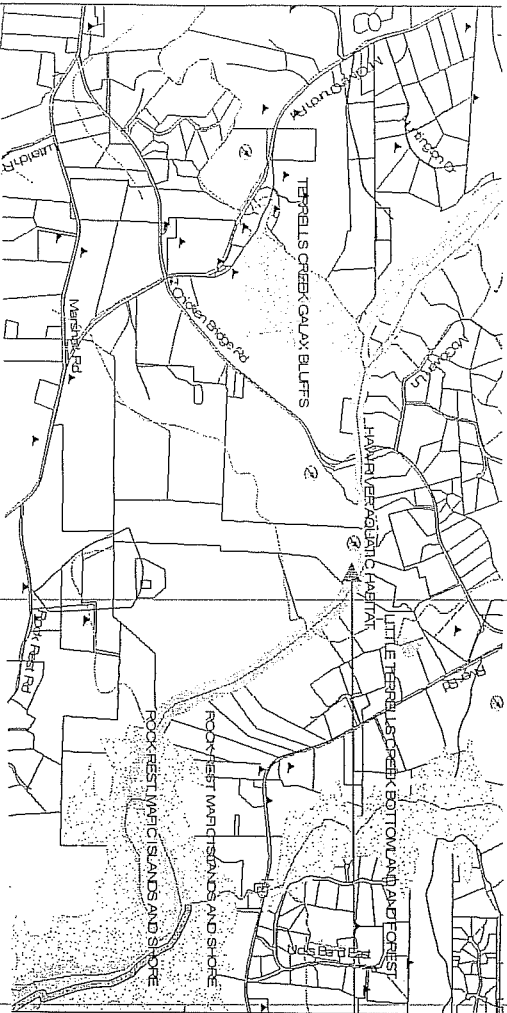

**Archeological Site Info.**

Site ID#: CH452  
 UNC Chapel Hill excavated the site in 1983 and 1986 and has published info on it. It is known as the "Mitchum Site" and contains a Native American child's grave, 14 artifacts (both from the Archaic age and European contact), postholes, and probably more graves. This site was occupied off and on for a very long time. Dolores Hall recommends (1) that the Planning Dept. and Developer contact the Research Lab of Archaeology to determine the boundaries of the whole site (Steve Davis 962-3845, [lpstdavis@unc.edu](mailto:lpstdavis@unc.edu)); (2) not to build on this site but preserve it as open space and have more excavations done. The archeological site to the southwest of CH452 is known as CH478 and is not part of the Mitchum Site, nor is it considered "significant."
