Dear Mr. Ashness:

Personnel assigned to this office have conducted a review of the permit Application and approval is granted subject to the following stipulations:

- The entrance onto NC 751 is to be constructed in accordance with the attached detail sheet.
- The entrance onto NC 751 shall be paved for at least 50° along the centerline of the entrance.
- The entrance onto NC 751 shall require radii on each side of the driveway as shown on the attached drawing. 3.
- No parking or outdoor advertising (signs) shall be allowed inside the right of way of NC 751.
- Any areas inside the right of way disturbed during construction shall be seeded and mulched immediately upon completion of construction.
- 6. This driveway permit accompanies Enc. # 19-3424 and is approved based on this encroachment for the widening of NC 751 having been completed as per approved plans and special provisions.
- Upon completion of construction, final approval by the District Engineer is required prior to opening the access connections for public use (page 9 Driveway Manual).

Attached to this correspondence please find an approved copy of TEB Form 65-04 (Driveway Permit Application - N. C. Department of Transportation). Upon completion of the driveway entrance construction please notify the Chatham County Maintenance Department (Phone 919-742-3431) so a final inspection of the entrance can be made.
