I reviewed the plat and we have one problem. Wynwood Drive is going from cul de sac to cul de sac and we cannot do that. It causes too much confusion for emergency responders. You can use N Wynwood Drive and S Wynwood Drive or you can keep the right side Wynwood Drive and name the left side something else. This is where The Glens Drive intersects Wynwood as you come into the subdivision.
