Re: Briar Chapel – Great Ridge Parkway Right-of-Way Dedication

Introduction / Background / Previous Board Actions:

See major subdivision application and preliminary map for background information.

This request is a portion of the Briar Chapel Planned Residential Development, consisting of 2,389 dwelling units on 1,589 acres, located off Hwy 15-501 N and Mann's Chapel Road, SR-1532, approved by the Chatham County Board of Commissioners on February 15, 2005. Issues for Further Discussion and Analysis:

The developer is requesting preliminary approval of Great Ridge Parkway, a proposed public, state maintained road. This preliminary approval request is only for Great Ridge Parkway which will provide access from S. R. 1532, Mann's Chapel Road to the development.

The Chatham County Emergency Operations Office has approved the road name Great Ridge Parkway.

Recommendation: The Planning Department and Planning Board recommend granting subdivision preliminary approval of "Briar Chapel – Great Ridge Parkway Right-of-Way Dedication" with the following condition:

1. Construction of Great Ridge Parkway shall not commence until staff has received a copy of the commercial driveway permit.
