## Hi Keith,

Thank you so much for the commitment you have made to get the new ordinance right. It will give Chatham County what it needs to grow gracefully.

As you update Draft Rev. 4, I encourage you to seriously consider all of the points I made in the original document I sent to the Planning Board and the comments I made at the Planning Board meetings. If properly integrated into the final ordinance, we should achieve a more workable process than would flow from the current Draft. And, given the progress made at past Board meetings, we should expect little or no public opposition to the new Ordinance.

I also thank you for the Outdoor Lighting information from the power companies. If these fixtures are in compliance with the new Ordinance, they will probably meet our daytime appearance needs. A better match would be achieved if Duke Power provided a fixture with a plain Top Hat as does Progress Energy. The additional decorative elements serve to differentiate them more than bring them into the same family. While the spacing of these products may overcome aesthetic differences in the daytime, we may find significant differences at night. Can you get Bob to comment on their night time similarities. Often the globe are made of different materials, which produce entirely different looks when lit up at night. I hope Bob will be able to remove this concern.

Keith, thank you for your good work. I stand ready to help where I am needed and look forward to the completion of the Outdoor Lighting Ordinance.
