**Telecommunications Meeting 7 May 2008: Verticality Inc. Build Plan**

I am pleased to confirm Verticality Inc.'s intention to attend the County of Chatham Telecommunications Meeting scheduled for 7 May 2008.

Verticality Inc. is a cell tower developer with locations in NC, SC, FL, GA, VA, MD and PA. Verticality has identified seven possible locations in the County of Chatham where it may be interested in construct towers and requests that Chatham County approve these as potential search ring locations. These towers locations have been selected to address multiple wireless carrier coverage gaps. Verticality intends to make these towers available to all wireless carriers operating within the county.

As required by the Chatham County ordinance, Article III 2(b) enclosed are search ring maps for each proposed tower, along with a map identifying existing towers within a 6 mile radius and RF coverage maps showing possible coverage before and after construction of the proposed towers. Also enclosed are overview maps of the County indicating the location of the proposed search rings and showing the possible RF coverage in the area of the proposed sites before and after construction.

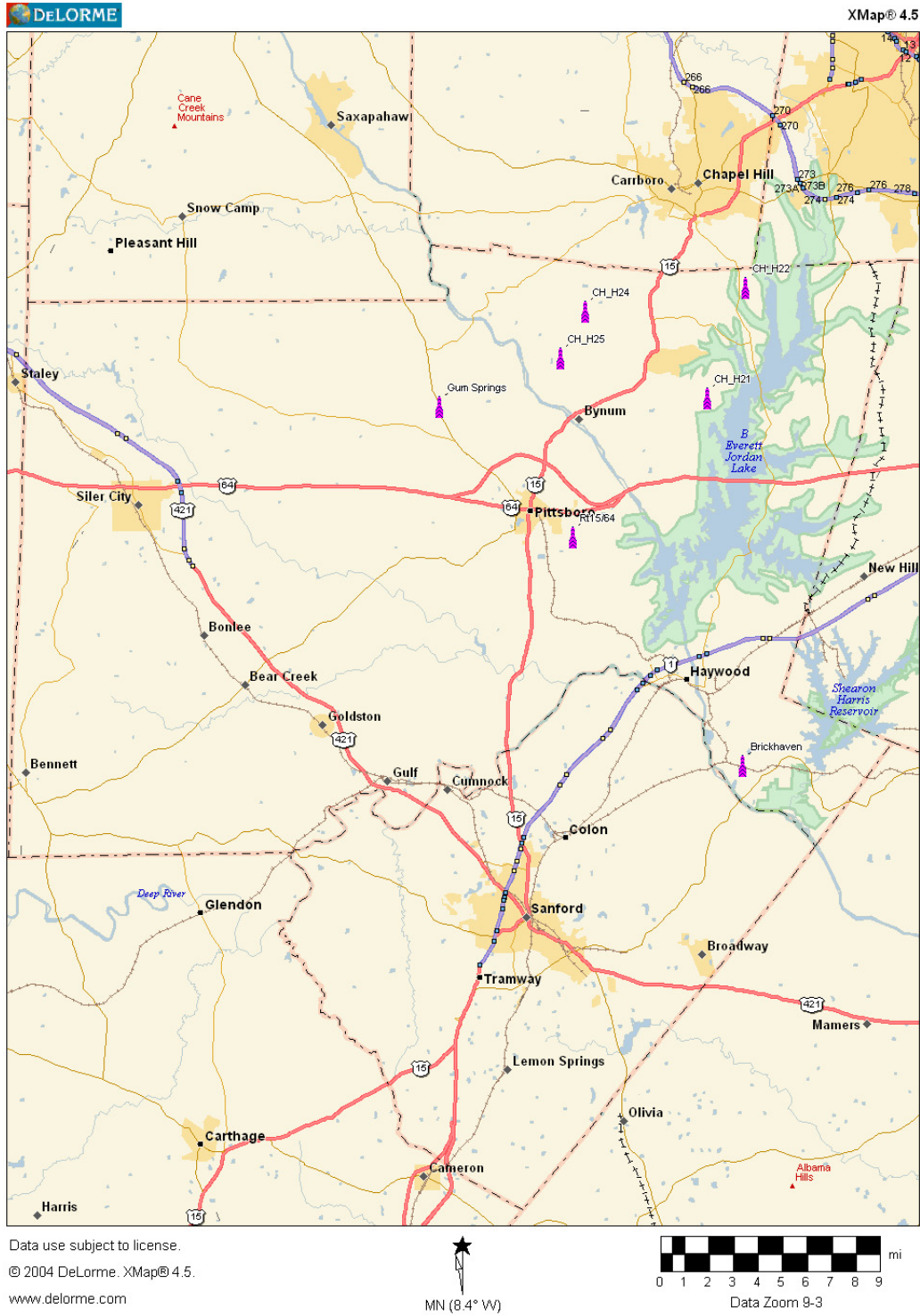

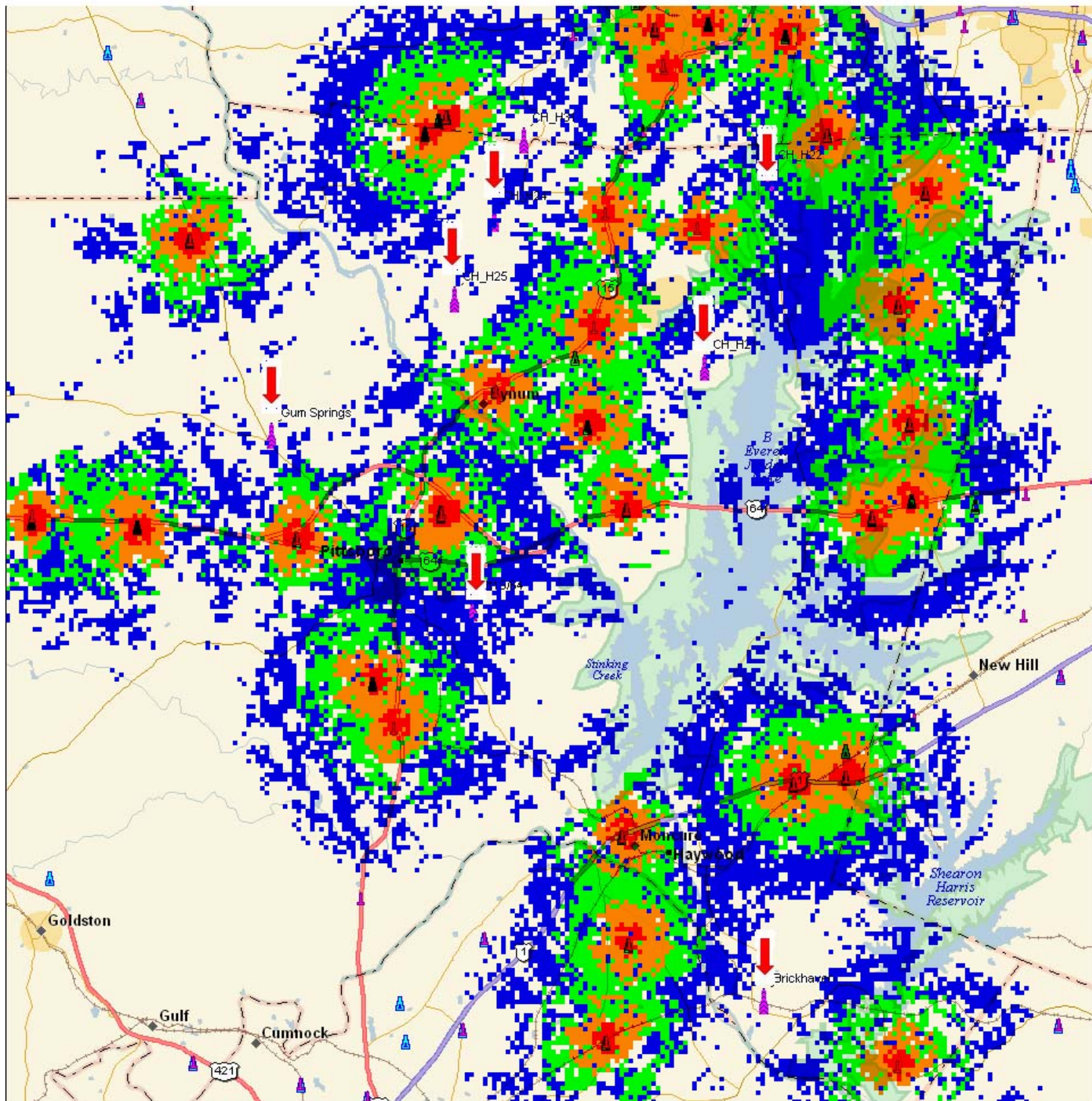

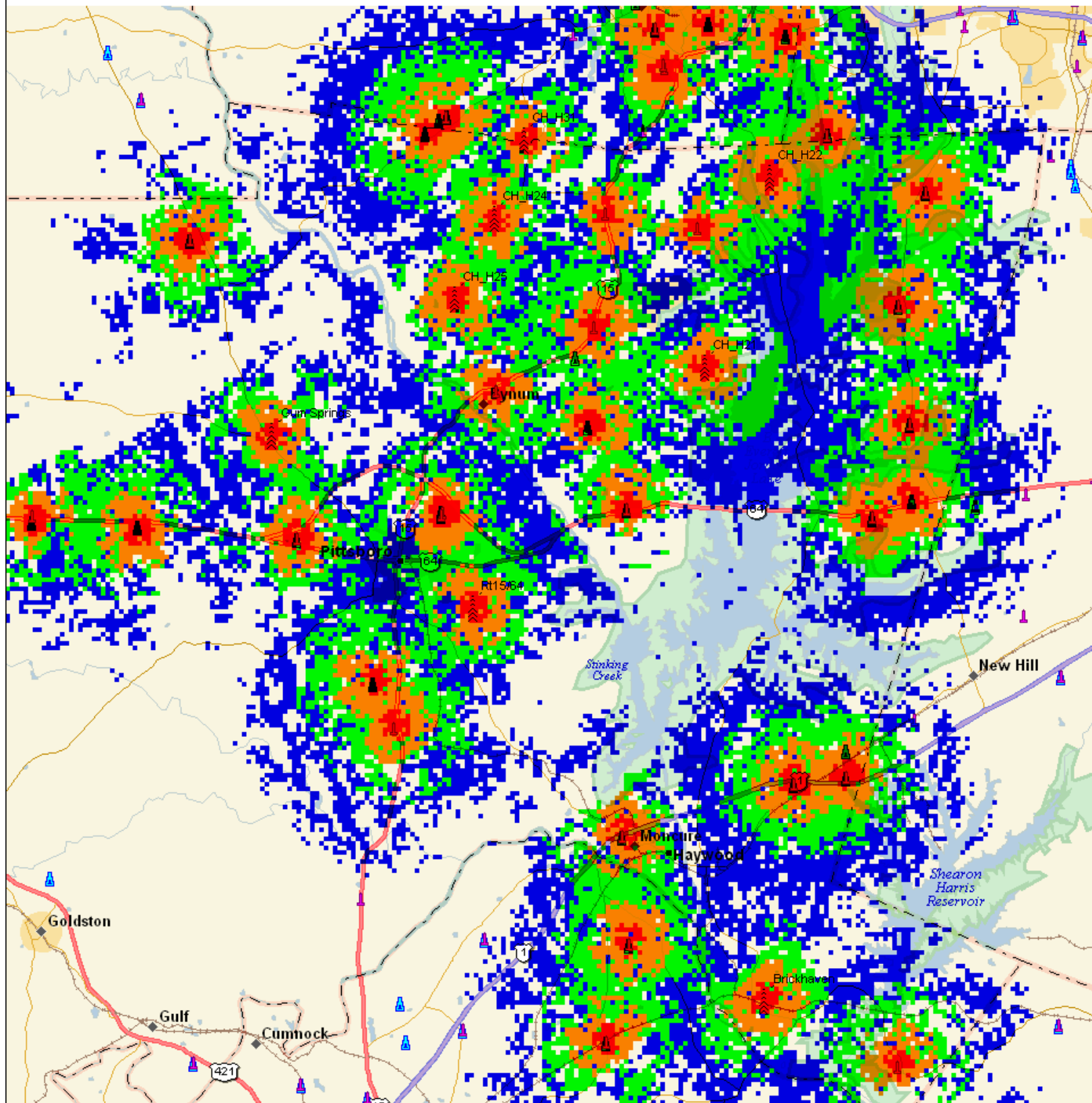


Current possible RF coverage in vicinity of proposed Certicality sites
