RE: Briar Chapel: Request for Compact Community Ordinance ("CCO") Waiver to Ratify Previously Installed Drainage Structures and Minimal Grading

Dear Board of Commissioners:

This letter serves as a formal request by NNP-Briar Chapel, LLC for a Waiver under the CCO to ratify the location of two previously installed drainage pipes and outlets, as depicted on <u>Attachment 1</u> (the "Pipes").

The Pipes were installed approximately ten years ago in accordance with approvals from DENR prior to delegation of the erosion control process to the County. The as-built locations of the Pipes encroach on a ten foot no-build zone in one case and on the no-build zone and buffer in the other case. Upon joint review, it is the opinion of the NNP engineers and the County Staff that, based on the length of time the Pipes have been in place, it would do more harm than good to the applicable buffers to extricate the Pipes and re-install them outside the buffer(s).

As I am sure you recall, the Compact Communities Ordinance ("CCO"), Section 15, authorizes the Board of Commissioners to adjust, modify, reduce or waive requirements of the CCO. There is a reasonable nexus between the request and the impact of the compact community.

In addition, NNP seeks to obtain this waiver because it has a pending erosion control application for the Boulder Point Drive extension that is being held in abeyance until this waiver is approved. Depending on a DOT determination, the Boulder Point Dr. Extension may require a minimal amount of grading within the buffer area (the shaded area shown on <u>Attachment 2</u>). This waiver includes a request to approve a waiver to allow this modest amount of potential grading within the buffer area as shown and described in <u>Attachment 2</u>.

Jeff,

Good talking to you yesterday. I worked on re-grading that bank on that western stream buffer at Boulder Point to get that wall off of that existing 36" RCP storm pipe. I think I have managed to get it to work with 2:1 grades. We may need to rip rap the slope or at least put some geotechnical fabric on it, but it will work. Hopefully this alleviates your and Hydro's concern about the retaining wall. I confirmed with you that the material was RCP and that we had sent calculations for those pipes which you forwarded to Hydro.
