Thank you for giving the okay for that to happen. Their conclusion was that the houses aren't very significant by themselves. The agreed with 1980s surveyor that it was the ensemble of buildings and context that made the site historically interesting. They didn't think anyone would go to the expense of moving the houses. They were appreciative of your willingness to let neighbors use materials from the buildings, as are we. Judith Peterson, my husband Jim and I visited the site on Monday and took a lot of photos. We'll make those a part of the CCHA archive, along with whatever information about the past residents of the property that I can dig up. The three of us who visited think that someone might be interested in salvaging some materials from the houses. Many of the doors might be of interest, especially the two or three board and batten doors, if those are old. There's a little cupboard hanging on the wall in the tenant house that someone would probably save, and some nice wide boards on the walls in the front room of that house. There may be more materials that would be of interest to someone who does deconstruction and salvage. We couldn't get a good look at the floor boards, and we don't know what's under the sheetrock in the main house. If the buildings are to be demolished, you might at least invite a salvage person or two to take a look. I don't think any of the materials are old enough to have great value, but these days people appreciate the quality of old wood and it might be worth someone's time and effort to save some of it. we noted that there were two tobacco barns shown on the 1980s survey of the property--on the far side of the pond. We didn't see those, but didn't walk to the other side of the pond to look closely. If they are gone, do you know what happened to them or, if they were removed, when that happened? Mr. Stone had mentioned some photo albums in the tenant house. We took a quick look at those but it didn't appear that most of the people and places pictured were in Chatham. I did take a photo of Mr. Goodwin's graduation certificate from the old Bell's High School. We left everything as we found it. You were going to forward an email from the person who is salvaging wood from the barn. I would like I may want to talk to her as well to get more of the history and to to see that. know a little about how they are using the wood.

If you speak to Mr. Stone, please thank him for us as well, and give him our best wishes for a speedy recovery. I purchased this property from Paul W Goodwin in 2004 and leased it back to him for a few years for personal home. He got remarried and moved somewhere else in Apex several years ago. > The 6 acre tract with the houses was part of the family farm until I purchased the tract where Builders is now located (1987 I believe ) from Paul and he wished to keep the home and 6 acres. The site where John Deere is located on the West was also part of the original farm but Paul had sold that to another man when I met him. > > As I understand and remember it, Paul's brother had lived in the home > and when he died left the farm to Paul and his wife. They moved there and planned to build a new home where the other house on site (but not on a foundation, west side of the main home) was situated.
