Dear Ms. Richardson:

As owners residing at 302 Fieldstone Lane, Pittsboro, North Carolina, we are writing in response to the above-referenced application to express our deep concern and objection to the proposed development of Parcel #80775. For the reasons stated below, although we have no objection *per se* to the extension of Fieldstone Lane and construction of 13 new homes on Parcel #80775, the concurrent establishment of a 50 foot wide public right way for access to Willow Way Road and the public golf course, and the likely future construction of a road on that public right of way for access to future development on Parcel #2613, will materially alter the character and safety of our neighborhood.


Specifically, we purchased our home on Fieldstone Lane, and paid an extra premium for the home, based upon the fact that Fieldstone Lane ended with a cul-de-sac, and there was no access from Fieldstone Lane to Willow Way Road and the public golf course, which area is currently separated from Fieldstone Lane by the undeveloped Parcel #80775. This geographic isolation provides a unique neighborhood for raising our children by significantly minimizing vehicular traffic and other safety concerns that come from public use of a roadway. Occasionally, however, patrons of the public golf course will inadvertently use Fieldstone Lane in an effort to access the public golf course because their GPS devices will direct them down Fieldstone Lane. Many times we have had to intercept speeding vehicles on Fieldstone Lane in order to avoid injury to our children who use the roadway. The creation of the 50 foot wide public right of way for access to Willow Way Road and the eventual construction of a public road on that right of way will turn our safe road into a primary means of ingress and egress for patrons of the public golf course and any future development on Parcel #2613.

The net result of creating this new public right of way will be to materially alter our neighborhood, increase the danger to our children, and negatively impact upon the value of our property. Although an extension of Fieldstone Lane for the 13 new homes which maintains the


secured cul-de-sac and security of the neighborhood is fine, this development should not include the establishment of a public right of way to Willow Way Lane. We would respectfully request that the approval of this development be expressly conditioned upon ensuring that Fieldstone Lane not be connected to Willow Way Lane and the public golf course in any way and the County maintain the safety and character of the neighborhood.

We invested substantial monies in agreeing to live here and raising our children. It would be fundamentally unfair to deprive us of this property right by radically altering our neighborhood.
