Our screening plan and fence surrounding the property seemed to address any concerns about dogs wandering off or onto the property. In addition, no dog will be outside unattended.

We have clearly specified that all dogs will be kept inside at night to address any concerns about us adding outdoor kennels.

We presented information about our septic plan and desire to seek a recycle permit with the State. Our wastewater disposal plan seemed acceptable by residents at the meeting.
