SUBJECT: Award a Contract (\$220,670) 2007 Concrete Repair Project to CJ Concrete Construction, Inc.

RECOMMENDATION:

Staff recommends that the City Council pass a motion to award a contract for the 2007 Concrete Repair Project to CJ Concrete Construction, Inc. in the net amount of \$220,670.

FISCAL IMPLICATION:

The budget for this project is \$223,000. Funds for this project are included in the 2007-08 Capital Improvement Program, TDA Funding, Facilities Maintenance and reimbursement through the State of California, Department of Transportation (Caltrans) for work performed on Sepulveda Boulevard (attachment "A").

BACKGROUND:

This contract is part of the City's ongoing concrete repair and maintenance program, although it has been over five years since this work has been performed and there are significant areas of need for concrete replacement. The concrete repair program addresses the routine and ongoing need to provide safe and conforming streets, sidewalks, curbs, gutters and upgrades such as the installation of new American with Disabilities (ADA) access ramps. Traditionally, staff coordinates concrete repairs to coincide with, in whole or in part, with established maintenance districts. The goal is to provide a programmed approach to street maintenance in which street, sidewalk and traffic markings are scheduled to coordinate and enhance the City's larger street projects. Benefits include regularly inspected streets, sidewalks, traffic markings and competitive pricing through economies of scale (attachment "B").

Most of the concrete repairs coincide with the location of street trees and are the direct result of root intrusion and subsequent displacement. Staff has omitted the sidewalk portion of the repairs on this contract pending further review of current sidewalk and tree policies and the study of alternative parkway design standards, tree selection and funding strategies. Some areas of potential study include the development of a root pruning, root barriers and deflectors, tree selection and

maintenance practices. As an interim measure, staff will grind and ramp less severe irregularities to eliminate any potential trip and fall issues. In those select areas where ramping or grinding will not provide adequate mitigation, the concrete will be removed and replaced with asphalt until such time that tree and sidewalk policies are reviewed or otherwise directed by the City Council.

DISCUSSION:

The majority of the concrete repairs are for residential streets located in the Liberty Village area of the City. Other locations include the west side of Sepulveda Boulevard between Rosecrans and Marine Avenues, Civic Center area, and ADA access ramps on Redondo and Magnolia Avenues. There are approximately 128 separate locations scheduled for repairs on this contract. (attachment "C")

Environmental Review

In accordance with the California Environmental Quality Act (CEQA) of 1970, this project is Categorical Exempt (Section 15301, Class 1(c)). Upon approval of award of contract, a Notice of Exemption will be filed with the County Clerk's office.

Bid Proposals

The project was advertised for bids in accordance with the City's standard operating procedures. Bid advertising information was provided to the publisher of record. Specifications were provided to twenty contractors, subcontractors and material suppliers. A total of nine competitive bids were received and opened on August 1, 2007. The bids ranged from the low bid of \$220,670, by CJ Concrete Construction, Inc. to the highest bid of \$331,012.00. CJ Concrete Construction, Inc.'s bid was reviewed by the Public Works Department and found to be responsive and in conformance with prevailing concrete prices. (attachment "D")

Two contractors were eliminated due to contract non-compliance.

Representatives of cities where work has been performed by CJ Concrete Construction, Inc. have indicated that the work performed was to their satisfaction. The project was discussed with a representative of the firm and he expressed confidence in his bid and a desire to perform the work.

CONCLUSION

Staff recommends approving the 2007 Concrete Repair contract to CJ Concrete Construction, Inc.. The bid proposal provides a complete package that will deliver the appropriate level of concrete repair work consistent with the expectations of the contract.

ALTERNATIVES

The alternatives to the staff recommendation include:

- A) Approve the award of a contract for the 2007 Concrete Repair Project to CJ Concrete Construction, Inc.
- B) Provide other direction


