SUBJECT: Consideration of Donation of Eight Used Shotguns to the San Diego

Community College Police Department

RECOMMENDATION:

Staff recommends that the City Council approve the donation of eight used Smith & Wesson shotguns to the San Diego Community College Police Department.

FISCAL IMPLICATION:

These items have a market value of \$50-75 each. Therefore, the total value of the donation is approximately \$600.

DISCUSSION:

The San Diego Community College Police Department (SDCCPD) is a small 24/7 agency which provides services to 14 different campuses in their district and operates under financial restraints regarding equipment purchases. The donation of eight surplus shotguns will greatly enhance the capabilities of the SDCCPD officers during the performance of their law enforcement duties.

These shotguns were initially purchased in the mid 1980's and deployed in detective units. The guns were subsequently designated as less-lethal "bean bag" guns and the stocks were painted green. When the Department standardized the issued shotgun and type of less-lethal munitions, these shotguns were retired from service.

The shotguns are not considered a restricted weapon. State law allows the direct transfer of the shotguns from the Police Department to another police agency without going through a firearms dealer. These guns are being donated with the green stocks intact since SDCCPD plans to use them as less-lethal guns. Staff will ensure that a release of liability form is obtained prior to transfer.

A formal letter of request for this donation has been received and it is attached for your reference.
