SUBJECT:

Accept Real Property Dedication at 1500 Rosecrans Avenue for Street Purposes

RECOMMENDATION:

Staff recommends that the City Council pass a motion to adopt Resolution No. 6124 accepting a real property dedication for street purposes at 1500 Rosecrans Avenue.

FISCAL IMPLICATION:

There are no costs associated with the acceptance of this real property dedication for street purposes.

DISCUSSION:

One of the street improvements recently completed on the south side of Rosecrans Avenue at Market Place was the construction of a right turn pocket for eastbound traffic to go southbound on Market Place. The owner of the property at 1500 Rosecrans Avenue is therefore dedicating to the City the area on the southwest corner of Rosecrans Avenue and Market Place where the improvements had been constructed. The property owner is dedicating the right-of-way to the City at no cost to the City. Resolution No. 6124 therefore provides for the City to accept this real property dedication for street purposes.

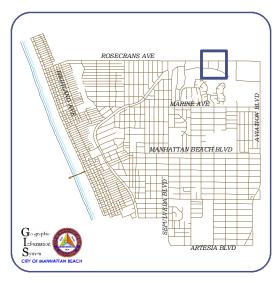
