SUBJECT: Review of Conceptual Design for Replacement of Play Equipment in Polliwog Park

near Redondo Avenue

RECOMMENDATION:

Staff recommends that the City Council approve the conceptual design for the replacement of play equipment in Polliwog Park near Redondo Avenue.

FISCAL IMPLICATION:

Funds in the amount of \$1,145,000 are included in the current Capital Improvement Program budget for the design and construction of this project. The City will be spending \$110,840 for the design contract with David Volz Design (D.V.D.), leaving \$1,034,160 available for the construction of the projects. A \$90,000 reimbursement grant has been awarded to the City by the California Integrated Waste Management Board for the purchase of rubber tire recycled materials which will be used as the surface material at the Polliwog Park site. The initial purchase of the materials will be made by the City, with \$90,000 being reimbursed at a later date.

The following chart illustrates the construction costs for each component of the original project scope to meet a balanced budget, as well as the costs associated with the optional exercise equipment, swings or additional play pieces. The third column presents the cumulative costs for each added project, as well as any remaining project budget.

BACKGROUND:

As noted in Fiscal Implication, the replacement of play equipment in Polliwog Park is one of four parks receiving replacement play equipment. During the February 19, 2008 Council Meeting, Council directed David Volz Design team to begin construction documents for replacing play equipment at Heights, Village and Marine Avenue Parks. It is estimated that after replacing the equipment at Heights, Village and Marine, there will be \$638,759 for the Polliwog Park project.

During the February 19 City Council meeting, Council directed staff and David Volz Design (D.V.D.) to return to Council with a final design showing play equipment that was of the traditional ramp and platform design which is a continuous play piece. Council also requested that the design include losing no trees and that any new trees planted not be palms. Council also stated that D.V.D. should design a less expensive way of fixing the drainage problem. Council also stated that the new plan should be on budget; however, the exercise equipment and a few of the prior play pieces that were shown to Council, which were for children of special needs, should be shown as additive alternates.

DISCUSSION:

Based on Council's direction from the February 19 meeting, staff and D.V.D. developed a plan using the play piece that was the traditional ramp and platform continuous play piece that Council liked. The other play pieces and exercise equipment that are additive alternates will also be shown how they too can fit into this area without removing any trees. During Tuesday's meeting, D.V.D. will show slides of what can be purchased and meet the budget (Attachment A) and what can be installed with additional funds (Attachment B). To meet the budget, it is estimated that only the ramp and platform continuous play piece can be installed. It will take an additional \$230,069 to install either swings or two additional play pieces that were previously shown to Council. It will take an additional \$38,500 to replace the exercise equipment. Attachment C details the costs of the two plans plus the exercise equipment.

It should be noted that staff has received a memo from the president of the Manhattan Beach 10K Run Committee stating the executive board approved recommending to the full board the donation of \$35,000 to the City for the exercise equipment. The Manhattan Beach 10K run committee has purchased and installed many par course stations throughout the city. The full board will vote next month on the recommendation.

Also, what is not included in the estimates in Fiscal Impact is the \$90,000 grant the City will receive for the rubberized surfaces in the play area from the California Waste Management Board.


If approved during Tuesday's meeting, D.V.D. and staff estimate the entire project will be completed by December 15, 2008.


CONCLUSION:


Staff recommends that the City Council review the information presented and select a design that meets the budget or select a design with additive alternates that could cost approximately \$275,000 more than the budget.






PROPOSED IMPROVEMENTS
