SUBJECT:	Award a Contract (\$429,463.20) Section 3 and 4 Concrete Repair Project (Those Areas Bounded by Marine Avenue on the North, Artesia Blvd. on the South, Sepulveda Blvd. on the West and Aviation Blvd. on the East) to Sully-Miller Contracting Co.

## **RECOMMENDATION:**

Staff recommends that the City Council pass a motion to award a contract for the Section 3 and 4 Concrete Repair Project (those areas bounded by Marine on the North, Artesia on the South, Sepulveda on the West and Aviation on the East) to Sully-Miller Contracting Co. in the net amount of \$429,463.20.

# **FISCAL IMPLICATION:**

The budget for this project is \$500,000. Funds for this project are included in the 2007-2008 Gas Tax Fund. Funds for the Annual Street Resurfacing Program (\$500,000) will be used for concrete repairs instead of street resurfacing for this fiscal year. The Street Resurfacing Program will resume during fiscal year 2008-09 after the concrete repairs are complete.

# **BACKGROUND:**

This contract is part of the City's ongoing concrete repair and maintenance program. It has been over five years since repair work has been performed in these sections and there are significant areas in need of attention. The concrete repair program addresses the routine and ongoing need to provide safe and conforming streets, sidewalks, curbs, gutters and upgrades such as the installation of new American with Disabilities (ADA) access wheel chair ramps. Traditionally, staff coordinates concrete repairs to coincide with, in whole or in part, with established maintenance districts. The goal is to provide a programmed approach to street maintenance in which street repairs, slurry sealing, sidewalk and traffic markings are scheduled to coordinate and enhance the City's larger street projects. Benefits include regularly inspected streets, sidewalks, traffic markings and competitive pricing through economies of scale (attachment "A").

Most of the concrete repairs coincide with the location of street trees and are the direct result of root

intrusion and subsequent displacement. Residents can avail themselves of the contractors concrete repair services while the contractor is on site, if they so choose. These repair services are a private business transaction between the property owner and the contractor, and the City's only involvement is to ensure the work meets City construction standards. Staff has omitted the sidewalk portion of the repairs on this contract pending review of current sidewalk and tree policies and the study of alternative parkway design standards, tree selection and funding strategies. Some areas of potential study include the development of a root pruning, root barriers and deflectors, tree selection and maintenance practices. Until such time that tree and sidewalk policies are reviewed or otherwise directed by the City Council and as an interim measure, staff will grind and ramp less severe irregularities to eliminate any potential trip and fall issues. In those select areas where ramping or grinding will not provide adequate mitigation, property owners will be notified to repair any portions of sidewalk or driveway that must be removed to reestablish original elevations.

# **DISCUSSION:**

The majority of the concrete repairs are contained within residential streets. Maintenance Sections 3 and 4 are contained within Marine Avenue on the north, Artesia Avenue on the south, Sepulveda Boulevard on the west and Aviation Boulevard on the east. There are approximately 256 separate locations scheduled for repairs on this contract (attachment "B").

# Environmental Review

In accordance with the California Environmental Quality Act (CEQA) of 1970, this project is Categorically Exempt (Section 15301, Class 1(c)). Upon approval of award of contract, a Notice of Exemption will be filed with the County Clerk's office.

# **Bid Proposals**

The project was advertised for bids in accordance with the City's standard operating procedures. Bid advertising information was provided to the publisher of record. Specifications were provided to twenty contractors, subcontractors and material suppliers. A total of five competitive bids were received and opened on April 9, 2008. The bids ranged from the low bid of \$429,463.20, by Sully-Miller Contracting Co. to the highest bid of \$668,320.00. Sully-Miller Contracting Co. bid was reviewed by the Public Works Department and found to be responsive and in conformance with prevailing concrete prices (attachment "C"). While the \$668,320.00 bid was received prior to the bid deadline and opening (Received on April 9, 2008 at 8:07 a.m), the bid was inadvertently misfiled to be opened at a different scheduled bid opening on the same subject date. Upon discovery, the Project Manager was notified and the bid was duly opened and recorded in the presence of the City Clerk and Senior Deputy City Clerk at 10:35 p.m. on the subject date. For legal purposes, the bid was recorded and distributed on this amendment. The results of the misfiled bid opening have no substantive effect on the bid results (attachment "D").

No contractors were eliminated due to contract non-compliance.

Representatives of cities where work has been performed by Sully-Miller Contracting Co. have indicated that the work performed was to their satisfaction. Sully–Miller is in fact currently performing satisfactory work in the City. The project was discussed with a representative of the firm and he expressed confidence in his bid and a desire to perform the work.

# CONCLUSION

Staff recommends approving the Section 3 and 4 Concrete Repair Project contract to Sully-Miller Contracting Co. The bid proposal provides a complete package that will deliver the appropriate level of concrete repair work consistent with the expectations of the contract.

# ALTERNATIVES

The alternatives to the staff recommendation include:

- A) Approve the award of a contract for the Section 3 and 4 Concrete Repair Project (Those Areas Bounded by Marine Avenue on the North, Artesia Blvd. on the South, Sepulveda Blvd. on the West and Aviation Blvd. on the East) to Sully Miller Contracting Co.
- B) Provide other direction
