Police Lieutenant Tony DiGenova provided an overview of the \$100,000 Supplemental Law Enforcement Services Fund (SLESF) Grant that was awarded to the City. He explained that it has been accruing interest and now totals \$107,500; that it must be encumbered by the end of this fiscal year; and that the Police Department anticipates fully expending these funds on the proposed purchases. He reviewed the brief history of the Grant and communicated that staff believes that the money would be best utilized in the following areas: traffic enforcement/education, communication, investigations, crime prevention, graffiti investigations and active shooter response. He then detailed the proposed equipment including: message board/radar trailers, a motorcycle and vehicle transport trailer, mobile data computers/radio equipment, a computer voice stress analyzer, a vandalism/graffiti deterrent system and the Instant Armor First Responder Tactical Blanket. In response to questions from Council, Police Lieutenant DiGenova explained that the blanket is a Kevlar type blanket that can cover several officers in situations where there is no available cover from fire and that the Purchasing Department will research the items under \$20,000 to get the best possible price.

In response to questions from Councilmember Ward, Police Lieutenant DiGenova clarified the functions of the message board/radar trailer; explained that the vandalism/graffiti deterrent system can be relocated to areas where crime occurs and that it has resulted in decreased violations; and that surveys on the voice stress analyzer have found the accuracy to be in the 90 percentile range.

Mayor Aldinger opened the Public Hearing at 7:54 p.m.

Hearing no requests to speak, Mayor Aldinger closed the Public Hearing at 7:55 p.m.

Councilmember Ward reiterated his concerns over the voice stress analyzer to which Police Chief Rod Uyeda responded that it would be difficult to "railroad" a suspect via the use of this equipment because the Police have to have hard circumstantial or physical evidence - it is simply a tool that helps determine whether they are on the right track.

Councilmember Tell pointed out that over 1,700 law enforcement agencies have been using this equipment.

<u>MOTION</u>: Mayor Pro Tem Montgomery moved to <u>adopt</u> Resolution No. 6134; <u>appropriate</u> SLESF Grant Funds and accrued interest for proposed expenditures; <u>waive formal bidding</u> per Municipal Code Section 2.36.140 (waivers); <u>approve</u> the award of to Kustom Signals, Inc. for message board/radar trailers in the amount of \$36,500 and to South Bay Regional Public Communications Authority for the purchase of mobile data computers and portable radios in the amount of \$31,000; and <u>approved</u> authorizing the City Manager to execute the purchase of other items listed in the staff report in an amount not-to-exceed the remaining SLESF Grant Funds and accrued interest (approximately \$40,000). 05/06/08-17. Consideration of Planning Commission Approval of a Zoning Code (Title 10)

Amendment to the Manhattan Beach Municipal Code and Local Coastal Program

Amendment Regarding the Prohibition of Medical Marijuana Dispensaries in All

Zones

Senior Planner Laurie Jester briefly reviewed that in 2006 the City Council adopted a temporary moratorium to amend the Zoning Code and temporarily prohibit medical marijuana dispensaries in the City. She explained that while the State currently allows these dispensaries, Federal law prohibits marijuana as a controlled substance. She reported that the Planning Commission determined that such dispensaries are not appropriate in the City due to the conflicting Federal law, potential Federal enforcement activities, probable crime and other disruptive affects. She acknowledged a position paper from the Beach Cities Health District (BCHD) explaining that the pharmaceutical product Marinol (a product similar to marijuana in relieving symptoms) is widely available; therefore they also would not support the introduction of medical marijuana dispensaries.

Council held a brief discussion with Police Chief Rod Uyeda and City Attorney Robert Wadden regarding a possible increase in crime and the conflicting state/federal laws.

Mayor Aldinger opened the Public Hearing at 8:05 p.m.

Hearing no requests to speak, Mayor Aldinger closed the Public Hearing at 8:06 p.m.

Councilmember Cohen emphasized that because there are dispensaries within reasonable proximity of Manhattan Beach and any resident requiring medical marijuana has "gotten it" elsewhere in the past, the City would not be taking something away. She added that because of the conflicting law, the possibility of federal agencies coming here and creating a local conflict and reasonable accessibility elsewhere, she would support a law prohibiting these dispensaries in the City.

Councilmember Ward thanked those individuals who shared their personal medical situations City Council Meeting Minutes of May 6, 2008

with him and emphasized that he cares about them and what voters choose to support. He spoke of an article in the *Los Angeles Times* regarding how medical marijuana helped people relieve their pain and resume a more normal life. He questioned the purpose of having local and state governments if the City acquiesces to the federal government and emphasized that he believes that the State's rights are paramount. Councilmember Ward stated that he believes that dispensaries could work in Manhattan Beach with proper controls; that he will probably be in the minority on this issue; and that it is time to treat people suffering from pain with humanity.

Mayor Pro Tem Montgomery stated the he does not believe that rights are being taken away from any resident to relieve their pain because there are other medical options available and because there are many options available outside of the City; he is in favor of making this prohibition permanent.

Councilmember Tell commented that because the BCHD is not in support of the dispensaries; the Police Department has indicated that there may be increased enforcement problems; and Manhattan Beach is such a small community, it is not appropriate to set up a test case here. He voiced his concern over those who may get a false prescription, take advantage of a dispensary to get an illegal drug and create crime in the area. Councilmember Tell added that because safety is emphasized in this community, as a community leader, he believes that a medical marijuana dispensary in Manhattan Beach is just not appropriate.

Mayor Aldinger commented that the state versus federal law is a dilemma, but many of those who voted for Proposition 215 are now saying that the law doesn't work. He stated that the fraud and distrust that these dispensaries bring is the main reason why he would oppose a dispensary; that the law needs to be changed; and that because marijuana is readily available, it is not right for Manhattan Beach.

Councilmember Ward questioned Mayor Aldinger on his source of information for this alleged fraud.

Mayor Aldinger explained that he watched a television special which showed that anybody can get a prescription for medical marijuana without showing the need for it and that the law needs to be changed because it is so "porously" written and that dispensary owners are basically selling marijuana legally.

City Attorney Robert Wadden read aloud the title of Ordinance No. 2114.

<u>MOTION</u>: Mayor Pro Tem Montgomery moved to <u>waive further reading</u> and <u>introduce</u> Ordinance No. 2114. The motion was seconded by Councilmember Cohen and passed by the following roll call vote:

05/06/08-18. Presentation of the 2008 Leadership Manhattan Beach "Project Lifesaver"

Charlie Bean, Leadership Manhattan Beach (LMB) Class of 2008 Project Leader, addressed Council with a PowerPoint presentation explaining the process whereby each class chooses a project that will enhance or give back to the community and how they implement it. She revealed that the class project for the LMB Class of 2008 would focus on emergency preparedness and be named "Project Life Saver." She explained that the Class' Mission Statement was to provide the community with the right tools and information in order to help themselves and others in the event of an emergency. She reported that the Class gave details about the distribution of the "Envelope of Life", 72-Hour Emergency Preparedness Kits and reusable grocery bags and reported that a "PDF" version of the "Envelope of Life" will be linked to the City's web site. Ms. Bean also spoke of fundraising efforts by the Leadership Manhattan Beach Class which raised over \$28,000 and the five different events where their projects were distributed.

The Council congratulated the **LMB Class of 2008** on a great project and <u>received and filed</u> the subject report.

<u>05/06/08-20.</u> Consideration of an Ordinance and Resolutions Approving Board & <u>Commission Modifications and Approval of Revised Board and Commission Handbook</u>

City Manager Geoff Dolan introduced this item reporting that City Clerk Liza Tamura will report on the specifics requested by Council and the subcommittee, consisting of Mayor Pro Tem Montgomery and Councilmember Cohen, will review the proposed changes to the Boards & Commissions Handbook.

City Clerk Liza Tamura reviewed the Council's directives of October 16, 2007 to amend the "Business Representative" Seat on the Cultural Arts Commission to a "Member-At-Large" Seat and require that the person chosen to fill the "Business Representative" Seat on the Parking and Public Improvements Commission own or operate a business located in the City, excluding home based businesses. She conveyed that the other requests, to include "special meetings" when determining absences and allow a total of four absences (2 regular and 2 medical emergencies) within a 12 month period, would require modifying the current Ordinance. City Clerk Tamura added that requirements to amend the Board & Commission Handbook include allowing 14 days for a Commissioner to submit a letter of resignation before forfeiting their membership and continue requiring that Commissioners be registered voters within the City.

Council briefly discussed and clarified the "regular" and "medical emergency" absence issue.

Councilmember Cohen explained that Mayor Pro Tem Montgomery attended a Commission orientation in the City of Torrance, was very impressed with their process and handbook, and that the subcommittee used the City of Torrance's Handbook as a benchmark to create a new Handbook for Manhattan Beach. She acknowledged that they spoke with Department Heads and Commissions Liaisons and are recommending clarifying some of the unwritten historical procedures and relationships between Commissioners, Staff and Council. She stated that the subcommittee has suggested a process regarding Commissioners initiating a recommendation that is not a part of the staff report and that it would have to be approved by Council. Councilmember Cohen stated that she would like to utilize the talents of Commissioners and allow then to include their recommendations on the staff report and then let the Council decide whether or not to follow through with them. She also spoke of formalizing a once-a-year orientation training giving a thorough overview and question and answer period.

Mayor Pro Tem Montgomery commented that the subcommittee borrowed several features from the City of Torrance including adding a flow chart to the Handbook to help identify Council and various staff. He elaborated on Councilmember Cohen's comments about an orientation stating that he would like to see every Commissioner attend at least once and allow Commissioners to share their recommendations with Council as long as the proper protocol is followed. He also emphasized that the subcommittee wanted to clarify the "unwritten rule" that Commissioners will automatically get re-appointed.

Councilmember Cohen added that City Attorney Robert Wadden has added an explanatory "white paper" on the Ralph M. Brown Act, which is very important for Commissioners.

Mayor Pro Tem Montgomery also cited that the subcommittee is recommending that every Commissioner attend ethics training, although currently, only the Planning Commission is required to attend.

Council held discussion regarding the process whereby a Commissioner(s) could initiate an issue and there appeared to be consensus that it could be accomplished by the staff summarizing the issue or through a letter attached to the staff report.

City Manager Geoff Dolan stated that this process has only been used a few times, possibly because the process hasn't been communicated to the Commissioners.

A brief discussion between City Manager Dolan and Council took place regarding methods for Commissioners to communicate with the Council. Council concurred that a defined process should be clarified in the handbook.

Mayor Aldinger voiced his concern that it may be problematic to send every Commissioner to City Council Meeting Minutes of May 6, 2008

ethics training to which Councilmember Ward agreed stating that it may be "overkill".

Council continued discussion regarding whether or not Commissioners should be required to re-interview when their term expires and they wish to be re-appointed. Council concurred to add the following language to the handbook: "those Commissioners seeing re-appointment must reapply and submit an updated application. An interview with Council is recommended".

In response to audience comments Council agreed that Commissioner(s) may make requests to study other issues and/or make recommendations to the Council. These requests may be undertaken via the following actions: the minutes; as part of the recommendation in a staff report; or summarized within the Commission's action minutes. Council discussed whether it is necessary to receive full Commission minutes as opposed to action minutes, but no consensus was reached. All of Council concurred that all Commissioners should attend ethics training.

City Manager Dolan pointed out that staff has been informing applicants that the orientation will take place on June 10, 2008; therefore he requested that this item be "cleaned up" and brought back to Council along with the now vacant Parking and Public Improvements Commission Seat for the May 20, 2008 City Council meeting.

Hearing no objection, it was so ordered.

City Attorney Robert Wadden read aloud the title of Ordinance No. 2113.

<u>MOTION</u>: Mayor Pro Tem Montgomery moved to <u>adopt</u> Resolution No. 6136 clarifying the definition of "Business Community Member" and "Artist" for the Cultural Arts Commission; <u>adopt</u> Resolution No. 6137 clarifying the definition of "Business Community Member" for the Parking and Public Improvements Commission; and <u>waive further reading</u> and <u>introduce</u> Ordinance No. 2113 which amends the Municipal Code section pertaining to the "Forfeiture of Membership.
