#### V. GENERAL BUSINESS

### 02/0612.7 Sculpture Garden Proposal

The Commission reviewed the artists under consideration for the Sculpture Garden. In addition to those artists who were previously confirmed (Harmon Nelson, Nina Karavasiles, and Amos Robinson), there are four new art works for consideration; Deana Mando, a second work by Nina Karavsailes, Kent Kraber and Frank Mando.

Calls to the following artists are planned to determine if their art work is available and staff expects confirmation by the next Commission meeting: Steven L. Reiman, Robert Verhees, John Oleinik, Marian Zeldin and Stefan Verstappen.

The Commission identified three possible areas and decided on the Metlox and Civic Plaza as sites for the Sculpture Garden art work.

#### Metlox:

- 13<sup>th</sup> Street Plaza close to 13<sup>th</sup> street at the Shade Hotel's northwest corner.
- Metlox Town Plaza near the tree-covered tables and chairs area.

# Veteran's Parkway

- Outside Joslyn on the lawn in front of the Oasis room.
- North of the Veterans Memorial

#### C. Civic Plaza

- In front of entrance to Human Resources
- Northwest corner on Fire Department facility
- Near Police Deprtment on grassy planted area

Staff is scheduled to present the proposed art work for the Sculpture Garden to City Council on March 17. The San Diego Port Authority may loan the Commission the maquettes for the sculptures being recommended.

The Commission is scheduling a Special Meeting on February 26 from 10 a.m. to 12 noon in City Hall to finalize the Sculpture Garden selections.

The Commission reviewed designs and quotes from two sources for sculpture base. The price ranged from \$1,165 to \$1,735, depending on the base style selected. A quote for the base has been requested from Public Works.
