Los Angeles County West Vector Control Board

The primary objective of this Board is to create an environment favorable to humans and animals by lessening the effect that mosquitoes and other vectors have upon our lives.

The Los Angeles County West Vector Control Board - Board of Trustee Seat, is currently held by Collin Ron Cooper who is eligible for re-appointment. If Mr. Cooper is re-appointed to this Seat, he will serve a four-year term. First time appointees are appointed for a two-year term.

CONCLUSION:

All Board and Commission seats which are appointed/re-appointed tonight will commence as of June 1, 2009 and will continue through May 31, 2012, with the exception of Parks and Recreation Seat No. 7 (Mira Costa High School Student) which is a one-year term and the Los Angeles County West Vector Control Board – Board of Trustee Seat which will be a two or four year term.

While the deadline for the Boards and Commissions Interviews have passed, the City Clerk's office is still accepting applications until 3:00 p.m. on Tuesday, May 5, 2009. All applications received after the printing of this staff report will be made available to the City Council at the City Council meeting of May 5, 2009.

ALTERNATIVE:

It is also important to note that should an existing Board or Commission member be appointed to fill a vacancy on a different Board or Commission, it would become necessary for the City Council to implement the following procedures:

- 1) Declare the vacancy of the open seat.
- 2) Direct the City Clerk's office to post the notice of vacancy.
- 3) Appoint a member to fill the Board or Commission noticed vacancy at the City Council Meeting of May 19, 2009.
