SUBJECT:

Consideration of the Parks and Recreation Commission Recommendation to approve Additional On-Leash Dog Access along Specific Pathways in Polliwog

Park

RECOMMENDATION:

Staff recommends that the City Council approve the Parks and Recreation Commission recommendation for the following expansion of dog-on-leash access in Polliwog Park:

1. Establish on-leash dog access for the pathways along the southern edge of Polliwog Park (near Manhattan Beach Blvd.) and the pathway around Premier Field. Pathways that shall remain prohibited are those around the amphitheater, picnic areas, fitness area, and both of the playground equipment areas. (Please see Attachment A).

FISCAL IMPLICATION:

This expansion will require additional signage, mutt mitt dispensers and marking the designated walk paths. The estimated cost for these items totals \$1,450.00 and will be encumbered by the current Parks and Recreation operating budget.

BACKGROUND:

During the January 9, 2007 joint meeting of the City Council and the Parks and Recreation Commission, the Commission was given the go-ahead to hold discussions on future dog-access areas and dog-run sites; to revisit old sites and try to gain approval from the various neighborhoods, based on the success of the approved park access/dog run locations.

After the successful implementation of the new on-leash path areas at Sand Dune, Polliwog Park and the lower grass area of Bruce's Beach, the Parks and Recreation Commission approved the continued utilization of a dog committee comprised of Recreation staff and other community members to continue looking into future opportunities for additional dog runs and dog-on-leash

access to city parks. The Commission suggested that staff conduct community outreach regarding the formation of the dog committee.

DISCUSSION:

In preparation for these future projects, Parks and Recreation staff conducted community outreach regarding needed committee members. A press release was sent on November 26, 2008 inviting new committee members. These efforts resulted in four (4) new members of the committee (renamed Community Dog Advisory Committee).

The committee holds ongoing, monthly meetings, looking into each project area. The expansion of dogs on leash along pathways at Polliwog Park was selected by the committee as its next project.

In September 2007, City Council approved the committee's proposal to allow dogs-on-leash access along the westerly pathway in Polliwog Park (along Begg Field and Begg Pool). The current proposal seeks to expand the areas of on-leash dog access to the southern pathways of Polliwog Park and the pathway around Premier Field. These pathways were selected for this expansion because they are used specifically as thoroughfares by park users. The pathway around the upper playground area and all internal pathways were excluded from the committee's proposal so as to keep dogs from areas where large groups of people gather and remain, as well as from areas where ducks, geese, and other birds collect. Additionally, the amphitheater area was excluded from this proposal because of the frequency with which the area will be blocked off from dog access during such special events as Concerts in the Park. Staff and the committee believe that by excluding the amphitheater area, incidents of misunderstanding with dog owners will be avoided.

Extensive notification to the community was pursued in the preparation of this proposal:

- 1) A Public Notice was created, identifying proposed areas of expansion and sent to all residents living within a 500 foot radius of Polliwog Park on April 17, 2009 (please see Attachment B). This notice listed the date, time and location for the May 5, 2009 Community Dog Advisory Committee meeting, as well as information regarding the Parks and Recreation Commission Meeting on June 22, 2009.
- 2) The same notice was posted on the Recreation page of the City of Manhattan Beach website, along with a map of the proposed expansion, on April 17, 2009

These notifications informed the public of the proposals and invited them to attend a community meeting on May 5, 2009 to provide input. The notifications also informed the public of the date and time of the Parks and Recreation Commission meeting on June 22, 2009, when the committee's recommendations were discussed.

Staff received three email responses (five persons) to the notification (Attachment C) opposing the expansion of on-leash dog access at Polliwog. There were no members of the public in attendance at the CDAC meeting on May 5, 2009.

At the community meeting, staff and the committee discussed the history of the established dog

on leash-access areas, identified the new proposed expansion and described how the expansion would affect Polliwog Park and users.

Staff contacted the middle school principal on April 30, 2009 regarding the proposed expansion of on-leash walk-through access at Polliwog Park. Staff and the middle school principal explored their concerns with usage of the Polliwog Park path by students for fitness and exercise classes. They agreed that the weekday interactions would be minimal, since most dog owners walk before 7:30 a.m. and after 4:00 p.m. and felt that Parks and Recreation could mitigate any problems with signage and hour limitations. Staff did not see any conflict between activities in the park and the proposed walk-through because its location is out of the way of such activities. As in other park walk-throughs for dogs on leash, staff noted that the use is minimal and has no significant impact on park operations.

On June 22, 2009, this recommendation was unanimously approved by the City of Manhattan Beach Parks and Recreation Commission.

CONCLUSIONS:

Staff believes this is only a minor adjustment to the existing use for on leash dogs using the westerly pathway. The westerly pathway was approved for use by on-leash dogs in September 2007 by the City Council. Staff has not received one complaint since the westerly pathway was approved. In fact, staff has received a great deal of positive feedback from the community.

The committee and city staff will monitor and gather information through user surveys and contact with concerned neighbors as was done for the currently established dog paths and dog runs. If significant or chronic problems occur, staff will work with the committee and neighbors to find prudent solutions or discontinue the changes in use.

The Community Dog Advisory Committee (CDAC) is a sub-committee of the Manhattan Beach Parks and Recreation Commission designed to address the needs and concerns of residents regarding pets (dogs) in the community. This sub-committee is comprised of a group of volunteers and City Staff from the Parks and Recreation and Police Departments.

The CDAC has developed a proposal to present to the Parks and Recreation Commission. This proposal is for the expansion of on-leash dog access in Polliwog Park. At present, dogs are permitted on a walkthrough corridor, on-leash, along the western most path of Polliwog Park. The proposed expansion will include the pathways along the southern edge of the upper level of the park and the pathway around Premier Field. Pathways that shall remain prohibited are those around the amphitheater, picnic areas, fitness area, and both of the playground equipment areas.
