City Manager Dolan stated that the City awards the contract/agreement to the lowest responsible bidder and that we currently don't have any criteria to address Mayor Pro Tem Ward's concern. He further suggested that perhaps this matter be considered for the upcoming Work Plan meeting.

In response to Mayor Pro Tem Ward, City Attorney Wadden stated that there are cities that have adopted guidelines for responsible bidding/contracting, and that if Council desires to do so, staff would need that criteria spelled out so that it can be clearly articulated in an Ordinance.
