# **BACKGROUND:**

The City Clerk's office placed advertisements in the March 11, March 18, April 1 and April 15, 2010 editions of the Beach Reporter; on the City's web site (<u>www.citymb.info</u>); on the City's posting boards; announced the vacancies at the April 6, 2010 and April 20, 2010 City Council meetings; and sent out an e-notification asking community members to apply for upcoming vacancies on the City's Boards and Commissions. Interested individuals submitted applications to the City Clerk's office. The City Clerk's office also contacted current Commissioners and individuals who submitted an application within the last three years to ascertain if they were still interested in being considered for any of the vacancies listed above.

#### **DISCUSSION:**

## Parking and Public Improvements Commission (2 Vacancies)

The Parking & Public Improvements Commission (PPIC) is responsible for making recommendations to the City Council on policy matters pertaining to public parking, Capital Improvement Program review, and activities in the public right-of-way.

The Commission consists of five seats, three (3) Citizen-at-Large Seats and two (2) seats representing the Business Community. The Citizen-at-Large Seats are available to any member of the community, while the Business Community representatives must be owners, employees or officers of businesses located and operating within the City.

Seat No. 3 is a Member-at-Large seat held by Paul Gross who is eligible for re-appointment.

Seat No. 4 is a Business Community seat held by Lester Silverman who is eligible for reappointment.

#### Parks and Recreation (3 Vacancies)

Seat No. 6 is a Member-At-Large seat held by Lynn Harris who is not eligible for re-appointment due to term limits.

Seat No. 7 is appointed by Mira Costa High School (MCHS). At the time this report was printed, we had not yet received the MCHS appointment. Therefore, staff will return to the May 1, 2010 City Council meeting with the MCHS appointment for ratification.

## **Board of Building Appeals (1 Vacancy)**

The Board of Building Appeals meets on an as-needed basis and pursuant to provisions of the Uniform Building Code, hears requests for interpretation of the Uniform Code provisions, alternative materials and methods of construction. Per adoption of Resolution No. 5702 at the September 18, 2001 City Council Meeting, members shall be qualified by <u>experience and training</u> to review matters regarding Manhattan Beach construction codes, such as sub-standard building, housing conditions, dangerous structures, disabled access and matters related thereto. If there are insufficient applicants from the City's electors, then the City Council may appoint qualified members from other City Boards or Commissions. If there are insufficient applicants from current Boardmembers or Commissioners, the City Manager is then authorized to select the Building Official or designee.

Seat No. 4 is held by Heather Donaleshen who is eligible for re-appointment.

- 2) Direct the City Clerk's office to post the notice of vacancy.
- 3) Appoint a member to fill the Board or Commission noticed vacancy at the City Council Meeting of May 18, 2010.
