SUBJECT:	Adopt Resolution Amending the Revised Bail Schedule For Violations of the Manhattan Beach Municipal Code.

RECOMMENDATION:

Staff recommends that the City Council adopt Resolution No. 6265 adopting amendments to the revised bail schedule for violations of the Manhattan Beach Municipal Code.

FISCAL IMPLICATION:

While only a small percentage of revenue from bail is received by the City (the bulk of the funds go to the Court system) the Courts do look to the City's bail schedule in determining the appropriate amount of "city costs" which are often paid through plea bargains in lieu of fines. Since all of these funds go to the City and current revenues from "City costs" average about \$50,000 per year we can expect some modest increase in revenue from the proposed increase in bail amounts. Money from Municipal Code prosecutions goes into the City's general fund.

BACKGROUND:

On March 2, 2010 the City Council adopted Resolution No. 6247 approving a new bail schedule for municipal code violations. The revised bail schedule was submitted to the Los Angeles County Superior Court Bail Committee for approval. The bail committee, which consists of sitting Superior Court judges, recommended several revisions before it would approve the revised bail schedule. These revisions are adopted by resolution 6265.

DISCUSSION:

The bail schedule is used when an individual is cited for a municipal code violation and is unable to provide sufficient identification to ensure that they can be located if they fail to appear in court. The schedule is also used by judges when they issue bench warrants for those who fail to make mandatory court appearances for municipal code violations.

The Bail Committee felt that the description of violations for Manhattan Beach Municipal Code Section 3.16.020 (local Fire Code amendments) were vague. The Committee also noted that some infractions provided for a bail of \$120 and that Government Code section 36900(b) sets a maximum penalty for first offense infractions of \$100. The Committee indicated that it was inappropriate for a bail amount to exceed the maximum penalty for a misdemeanor since in most

cases the forfeited bail becomes the penalty for an uncontested infraction.

Resolution 6265 contains, as Exhibit A, a revised bail schedule with corrections to the description of Section 3.16.020 and revision to all infraction amounts of \$120 down to \$100.

Should the Council approve Resolution 6265 the amended bail schedule will be resubmitted to the Superior Court Bail Committee for approval and activation.

RESOLUTION NO. 6265

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, AMENDING THE REVISED BAIL SCHEDULE FOR VIOLATIONS OF THE MANHATTAN BEACH MUNICIPAL CODE PURSUANT TO RECOMMENDATINS BY THE LOS ANGELES SUPERIR COURT BAIL COMMITTEE

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, DOES HEREBY RESOLVE, ORDER AND DETERIMINE AS FOLLOWS:

<u>SECTION 1</u>. The Manhattan Beach City Council hereby makes the following findings:

- (a.) On March 2, 2010 the Manhattan Beach City Council adopted Resolution no. 6247 which implemented extensive revisions to the existing bail schedule for municipal code violation;
- (b.) Resolution no. 6247 was submitted to the Bail Committee of the Los Angeles Superior Court for review and approval;
- (c.) The Bail Committee made recommendations that the offenses under Manhattan Beach Municipal Code Section 3.16.020 were not clearly set forth and that some infractions set bail of \$120 which exceed the maximum bail amount of \$100 imposed by Government Code section 36900(b) for first offense infractions;
- (d.) It is therefore necessary to amend the revised Bail Schedule to reflect the changes requested by the Superior Court Bail Committee

<u>SECTION 1</u>. The City Council hereby amends Resolution 6247 to incorporate changes in the Bail Schedule incorporated in Exhibit A, attached hereto and incorporated herein by reference.

<u>SECTION 2</u>. By this resolution, the City of Manhattan Beach requests that the judges of the Superior Court for the County of Los Angeles approve the establishment, increase, and reduction, where appropriate, of bail for violations of the Manhattan Municipal Code as set forth in the Bail Schedule in Exhibit A.

<u>SECTION 3.</u> The Manhattan Beach Municipal Code designates that certain offenses thereof shall be misdemeanors. Certain of these offenses are designated as infractions for purposes of the Bail Schedule only. The designation of certain misdemeanors as infractions on the Bail Schedule applies only to violations set forth on a Notice to Appear citation form, issued pursuant to Penal Code Section 853.6. The designation of offenses and the bail contained in the Bail Schedule does not apply to formal criminal complaints filed by the City Prosecutor pursuant to Penal Code Sections 740 and 949. That is, notwithstanding the designations contained in the Bail Schedule, the City Prosecutor may initiate criminal prosecution by a formal complaint and charge the defendant with misdemeanor violations pursuant to the Municipal Code designation.

<u>SECTION 4.</u> This Resolution shall take effect immediately, except for the provision which repeals the existing Bail Schedule. Resolution 5798 is hereby rescinded in its entirety and replaced by this Resolution. The existing Bail Schedule shall not be repealed and replaced with the revised Bail Schedule until the latter is approved by all required Courts and becomes effective in the Los Angeles County Superior Court.

SECTION 5. The City Clerk shall certify to the passage and adoption of this resolution; shall cause the same to be entered among the original resolutions of said City; shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which the same is passed and adopted; and shall transmit this Resolution and Bail Schedule to the South Bay Superior Court.
