11/03/10-6. Consideration of Ratification of Motor Fuel Purchase from Nickey Petroleum in the Amount of \$21,219.36

The Council <u>approved</u> ratifying the subject purchase.

11/03/10-7. Consideration to Approve Additional Appropriations (\$163,749) and
Appropriation Modifications for Street Projects Funded with American
Recovery Reinvestment Act (ARRA) Stimulus, Los Angeles County Metropolitan
Transportation Authority (LACMTA), and Proposition 42 Funds in the Fiscal
Year 2010-11 Capital Improvement Program

The Council approved an additional appropriation of Stimulus Funds provided through the American Recovery and Reinvestment Act (ARRA) of 2009 in the amount of \$283,749 for the Pacific Avenue Resurfacing Project (Manhattan Beach Boulevard to Rosecrans Avenue) Project No. 11828E from bringing total ARRA funding for this project to \$543,749; approved a reduction in LACMTA fund appropriations in the amount or \$140,000 from the Pacific Avenue Resurfacing Project (Manhattan Beach Boulevard to Rosecrans Avenue), Project No. 11821E, eliminating LACMTA appropriations for this project; approved an additional appropriation of Proposition 42 Funds in the amount of \$120,000 for the 17th and 18th Street Resurfacing Project, Project No. 11820E, bringing total Proposition 42 funds for this project to \$180,000; approved a reduction in ARRA appropriations in the amount of \$100,000 from the 17th and 18th Street Resurfacing Project, Project No. 11827E, eliminating ARRA appropriations for this project; approved an additional appropriation of LACMTA funds in the amount of \$185,000 for the Rosecrans Avenue Resurfacing Project (Sepulveda Boulevard to Redondo Avenue), Project No. 11822E, bringing total LACMTA appropriations for this project to \$250,000; and, approved a reduction in ARRA appropriations in the amount of \$185,000 from the Rosecrans Avenue Resurfacing Project (Sepulveda Boulevard to Redondo Avenue), Project No. 11829E, eliminating ARRA appropriations on this project.

#### 11/03/10-8. Consideration of a Lease of Groundwater Rights from the City of El Segundo

The Council <u>approved</u> authorizing the Mayor to enter into an agreement to lease 953 acre feet of water rights at \$105 per acre feet from the City of El Segundo (total cost of the lease amounts to \$100,065).

11/03/10-9. Consideration to Execute a Program Supplement Agreement with Caltrans for

Adding Pacific Avenue Resurfacing Project Under the Existing Master

Agreement

The Council <u>approved</u> a Program Supplement with Caltrans for the Pacific Avenue Resurfacing Project and <u>adopted</u> Resolution No. 6284 authorizing the Interim City Manager to sign the program supplement agreement on behalf of the City.

11/03/10-10. Consideration to Approve Contract Agreement with AAE, Inc. for Design Services for the Fiscal Year 2010-11 and Fiscal Year 2011-12 Sewer Main Rehabilitation Projects, Not-to-Exceed \$109,770

The Council <u>approved</u> a contract agreement with AAE, Inc. to provide design services for the Fiscal Year 2010-2011 and 2011-2012 Sewer Main Rehabilitation Projects in an amount not-to-exceed \$109,770 and <u>approved</u> extension of the term of the existing as-needed professional services agreement with AAE, Inc. to June 30, 2012.

Fire Battalion Chief Frank Chiella discussed underground pipeline safety in Manhattan Beach and provided a PowerPoint presentation outlining where the pipelines are located in the beach cities.
