"This afternoon the City Council met in closed session and discussed the items that were listed on the posted agenda. The City Council asked me to provide as complete closed session report as possible under the circumstances.

We all understand, of course, that personnel matters involve individual privacy which is protected by law. However, by way of context, the City entered into an employment agreement with Bob Wadden in 1996 which has been restated a few times with adjustments in compensation. Mr. Wadden has served as the City Attorney for 15 years. The City Attorney serves at the pleasure of City Council.

Today in closed session the City Council voted unanimously, with Councilmember Lesser absent, to place Mr. Wadden on administrative leave for one week, effective immediately. The City Council will meet here April 5, 2011 at 1:30 pm, that's next Tuesday, to take action pursuant to his employment contract.

As I mentioned, and you all know, you must not discuss personnel matters, that admonition is especially important because we are engaged in an on-going process. When this procedure is complete we will have more information. That concludes my report."
