SUBJECT: Select Member for Los Angeles County West Vector Control Board – Board of

Trustee Seat

RECOMMENDATION:

Staff recommends that the City Council appoint John Frazee to the Los Angeles County West Vector Control Board – Board of Trustee.

FISCAL IMPLICATION:

There are no fiscal implications associated with the recommended action.

BACKGROUND:

On May 11, 2012, the City Clerk's Office received a letter of resignation from Collin Ron Cooper regarding his Board of Trustee seat on the Los Angeles County West Vector Control Board.

The City Council declared the seat vacant at its June 5, 2012 City Council meeting and staff advertised the vacancy in the Beach Reporter, posted the vacancy on the City Hall bulletin boards and web site, and sent out an e-notification.

DISCUSSION:

The Los Angeles County West Vector Control District is governed by a Board of Trustees. The regular meetings of the Board of Trustees are held every other month on the second Thursday of the month at 7:30 p.m. at the District's headquarters located in Culver City. The next meeting will take place on July 12, 2012.

A Trustee must be a resident and an elector (registered to vote) of the city from which he/she is appointed. Trustees who attend the regularly scheduled meeting are compensated with a payment of \$100 and by law Trustees must attend the meeting to receive this compensation. If additional meetings are necessary during the month, no addition compensation is awarded and no Trustee can receive more than \$100 per month for serving on the Board regardless of the number of meetings.
