Page 2: Robert Bush testimony: second line from the bottom: change "10th Street" to "8th Street"

- Pg. 12: Planning Commission Discussion; first paragraph (starting Commissioner Conaway..):
 - Second line from the beginning: strike "a lot and" so this line reads: "...Commission has sufficient information now....."
 - Sixth line from the beginning: strike "as" to read: ".....as a "highway" and more like the downtown for the local residents."
 - Ninth line from the beginning: strike "plus an additional" and replace with " with a" 3-ft furnishing zone"...... to read: "...1) an 8-foot sidewalk with a 3-foot "furnishing zone".....
 - Fourth line up from the end of paragraph: insert "in front of the driveway" after KEEP CLEAR marking on the street to read: "3) a midblock crosswalk to service employees crossing 8th Street from the north side parking lot, including "KEEP CLEAR" marking on the street in front of the driveway;".

Pg. 13:

- Third paragraph from top of page, first line: strike "while" and replace with "that" to read: "Commissioner Conaway stated that he loves and does not disagree with....."
- Fifth paragraph from top, last line: strike "is" and replace with "are" to read: "....outlet in that there are other parking alternatives that can be used for parking."
- In the motion: 3rd line: on item 1 of the motion: strike "plus an additional" and replace with "with a " to read: "1) an 8-foot sidewalk with a 3-foot "furnishing zone"......"

- In the motion, 7th line down: in item 3 of the motion: insert "in front of the driveway" after "markings on the street" to read: "....including "KEEP CLEAR" markings on the street in front of the driveway";
