RE: Storm Drain Property Acquisition

This is to provide a status report on the storm drain project and to request an adjustment in funding authorization.

Council approved Gilfilian's cost estimate and Administration's request to expend funds from Municipal Grants #86-314 and #85-163 as follows:





Per Council approval we requested Tryck, Nyman and Hayes (TNH) to review the design of the main storm drainage pumping station and other features of the project that could be affected by changes in the original TNH design such as changes in location of discharge, length, size and location of force main, etc. Attached to this memo is a report dated November 10, 1989, prepared by Mr. John Chapman of TNH which presents their review findings on this project.

Please note Mr. Chapman's recommendation for a geotechnical investigation on the proposed pump station site (Mr. Gisler's property - Lot 53, Snider Subdivision Addition No. 1). In consideration of the considerable cost for installing a large diameter well for the purpose of performing aquifer pumping tests, we recommend a conventional geotechnical investigation involving the drilling of two (2) 40-feet deep, strategically located borings to determine the lot's subsurface conditions. This information would be of value to determine the suitability of the lot for the proposed pump station improvements. The geotechnical investigation should be completed prior to the final purchase of Mr. Gisler's log.

We estimate the cost to conduct the drilling program and prepare the geotechnical report would be approximately \$ 5,995.00. It is our understanding there is sufficient funding remaining in the storm water design budget to cover these costs. This work could be accomplished this winter within a relatively short period of time.

SUBJECT: Work Order Budget on Storm Drain Project

This memo is to confirm my understanding of the results of our January 10, 1990 meeting concerning the budgets for the work orders issued on the subject project. As of December 31, 1989 the encumbered unspent budget on these work orders totaled \$5,431.49. Of this total, Work Order #88-13A has an adjusted balance of \$3,171.24 and a new Work Order #88-10A-1 will be issued for \$7,000.00 which would result in a net balance of \$2,260.25.

In addition, it is understood a memorandum prepared by you will be sent to the City Council for appropriating funds to perform a geotechnical investigation on Grissler's Lot 53 in Snider Subdivision. The proposal to perform the investigation contingent on an agreement to purchase Gissler's lot was approved by Council on for a budget amount of \$5,995,00. To accomplish this work, I would assume a new work order will be issued by you subsequent to Council action on appropriation.
