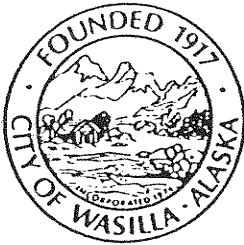
I have appointed Janice N. Daily to fill the unexpired term of Dean Beaulieu which will end December 31, 1990.


