SUBJECT: Council Compensation

Before you are Ordinances Serial No. 90-41 and 90-42 for your consideration. Passage of one or the other hopefully will establish clear policy reference compensation of Councilmembers.

Ordinance Serial No. 90-41

This Ordinance would establish the compensation paid to Councilmembers as Salary and would qualify Councilmembers to participate in PERS according to our Participation Agreement or they could waive participation by signing a waiver form. Passage of this Ordinance would also subject Council compensation to all other payroll deductions and taxes. Below is the Annual Fiscal Impact to the City and Councilmembers, assuming current pay and benefit/deduction rates.

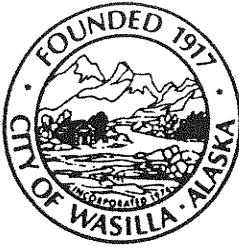
Ordinance Serial No. 90-42

ORDINANCE SERIAL NO. 86-20

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTER 2.04 BY ESTABLISHING AN HONORARIUM FOR CITY COUNCIL MEMBERS.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA:

SECTION I. CLASSIFICATION. This ordinance is of a general and permanent nature and shall become part of the City Code.

SECTION II. ENACTMENT. There is hereby added to the Municipal Code of Wasilla 2.04.040 (B), which is to read as follows:

2.04.040 (B) The compensation for each Council member shall be \$100.00 per month. The monthly compensation for each Council member shall be reduced for each regular meeting held during the month from which the Council member is absent except when excused because of a conflicting engagement of City Council business. The amount of each reduction is \$50.00. Increases in compensation shall take effect after the first election subsequent to the approval.

SECTION III. EFFECTIVE DATE. This ordinance shall become effective October 13, 1986.
