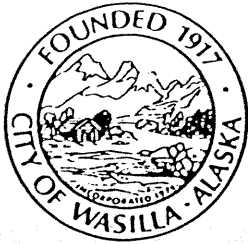
I have re-appointed Gene Wicker and John Hartrick to the Planning Commission for three-year terms ending December 31, 1993.
