RE: Road Improvements

Council appropriated \$70,000 in this year's Capital Improvement Program to begin a 5-year program of rebuilding high traffic gravel streets. Lake Lucille Drive was re-topped and dry wells were constructed on Nelson Avenue and Peck Street. There is about \$31,000 remaining for work planned next spring.

The next street scheduled for rebuild is Nelson Avenue. The portion of Nelson Avenue from Lucille Street to the intersection of Graybark, about 1,200 feet, is impossible to maintain in acceptable condition. A combination of poor sub-base and very high traffic that is accelerating and decelerating causes pot-holes and wash board within a day or two of each grading.

Administration recommends that we use the remaining FY91 road improvement funds (\$31,000) and the amount necessary from the \$182,000 legislative grant for street improvements to pave Nelson Avenue from Lucille Street to and including the intersection with Graybark Avenue. The total project should not exceed \$50,000.

RE: Road Repair Capital Improvement Fund

Council indicated an interest in a City Capital Improvement Fund and prioritization for repair of collector and commercial gravel roads. The intent is to provide new topping materials, place culverts and dry wells where needed, reshape ditch lines and brush ditch slopes. The goal is to establish a program to systematically prevent the total deterioration of high use gravel roads. Administration recommends an annual appropriation of \$70,000 (about 1/3 mill) which should sustain a five-year commercial/collector road repair cycle for about 10 miles of gravel roads.

Recommend Council approve the appropriation and authorization of \$70,000 as part of the FY92 annual budget to be placed in a Capital Improvement Fund for implementation of a road repair program as outlined above.
