RE: Ordinance Serial No. 92-01 (Substitute)

Establishing a Museum Department

Council introduced Ordinance Serial No. 92-01 to establish a Museum Department during the meeting of December 9, 1991. Administration recommends Council adopt Ordinance Serial No. 92-01 (Substitute) in lieu of the original draft for the following reasons.

As drafted, proposed ordinance places the specific duties responsibilities on the Wasilla-Knik-Willow Creek Historical Society which means that they would be performing activities on behalf of and authorized The status of the Historical Society officers or members as by the City. employees of the City becomes a liability issue under the proposed ordinance. If in the course of performing any of those related activities a liability should arise, the City's general fund could be subject to pay claims for medical and other expenses. The City's insurance would likely not cover the members of the Society unless we specifically insure them for worker's compensation and other benefits. To obtain this coverage the City would have to formally declare Society members as salaried employees.

Secondly, as drafted, the proposed ordinance is in conflict with Alaska Statutes and existing City Code that designate the Mayor as the appointing authority. Nowhere in the City Code or Statutes is there authority for persons who are not employees of the City to direct or supervise City employees while performing City duties.

Conversely, there is ample opportunity for the Historical Society to continue to contribute their volunteer activities in much the same manner as they do now. However, it is not advisable to give them potential employment status within the City administrative authority. We propose an arrangement similar to the Library which allows advisory participation by the Historical Society.

If Council wishes to establish a Museum Department, Administration recommends that Ordinance Serial No. 92-01 (Substitute) be adopted.

PRELIMINARY DRAFT OF ORDINANCE SERIAL NO. 91-25 AN ORDINANCE OF THE CITY OF WASILLA, ALASKA ESTABLISHING A MUSEUM DEPARTMENT.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA FOLLOWS:

<u>SECTION I.</u> <u>Classification.</u> This ordinance is of a general and permanent nature and shall become part of the Wasilla Municipal Code.

<u>SECTION II.</u> <u>Purpose.</u> The purpose of this ordinance is to establish a new department in the city government organization

<u>SECTION III.</u> <u>Amendments.</u> Title 2 of the Wasilla Municipal Code is amended as follows:

Chapter 2.58

Museum

Sections 2.58.005 Department Established

2.58.007 Mission

2.58.010 Appointment

2.58.020 Duties

2.58.030 Advisory Committee

2.58.040 Property and Collections

2.58.005 Department Established. There is established in accordance with Title 29 Alaska Statutes, the Museum Department.

<u>2.58.007 Mission.</u> The mission of the Museum Department is to collect preserve and utilize the Wasilla-Knik-Willow Creek area's natural, cultural and historic artifacts as cultural, economic and educational assets.

2.58.010 Appointment. The Mayor shall designate the Wasilla - Knik-Willow Creek Historical Society as the Appointing Authority for the position of Museum Department Head. (Chapter 3.80.010) The museum Director shall be appointed by the Board of Directors of the Wasilla-Knik-Willow Creek Historical Society with confirmation by a majority vote of the Wasilla City Council as provided in Chapter 3.20 of the Wasilla Municipal Code. The position of the Director is an executive position as provided for in Chapter 3.80 of the Wasilla Municipal Code.

<u>2.58.020</u> <u>Duties.</u> The purpose of the Museum Department is to provide personnel, materials and services for the collection, care, preservation, public display, educational and informational activities for items with historical cultural, or natural significance to Wasilla and environs (inclusive of Knik and Hatcher Pass Areas).

2.58.030 Advisory Committee. The Wasilla-Knik-Willow Creek Historical Society shall serve as the sole recruitment source for museum personnel. The Society will also provide administrative direction to the Museum Department insuring that operations are in conformity with the bylaws of the Society and the City of Wasilla Municipal Code. The Society will also serve as an advisory and support organization to the Director, the Mayor and the City Council.

2.58.040 Property and Collection and Proprietorship

- A. The Director shall maintain an inventory of all artifacts and historical materials in the possession of or entrusted to the Museum. The inventory data shall include information such as donor, prior and present owners status such as gift, donation or on loan, and historical significance.
- The Museum collection and real estate owned by the Wasilla-Knik-Willow Creek Historical Society prior to enactment shall property of the Society unless remain the specifically donated to the City at a later date. Management of the collection by the Museum Department shall be by agreement with the Society which will provide, as a minimum, that Museum Department shall not be liable for the property or artifacts from what ever causes and that management of the property and artifacts is a joint effort and responsibility of the Society and the Department.
- C. Property and artifacts acquired donated or offered for display in the Museum after the date of enactment of this chapter shall have clearly indicated on the inventory the owner or recipient as the City or the Society.

SECTION IV. Effective Date. This ordinance becomes effective upon mutual adoption by the Wasilla City Council and the Wasilla-Knik-Willow Creek Historical Society.
