Street Lights Phase III, Part 1

The State approved our request for \$50,000 to install Phase III street lights. With the \$12,000 appropriated by the Council, the total of \$60,000 should install about 40 new lights. Advertisements in the July 29 Frontiersman and the City news report have generated four new requests to date. A new map is on display in Council chambers.

Administration asks for Council approval to install the following lights prioritized from leftover Phase II nominations and new requests. The Part 1 list of 20 lights represents about one-half of the Phase III project. Remaining new lights can be done later. City will contract with M.E.A. using their A.P.U.C. approved rates and tariffs for street lights. Installation is conditioned on acceptable M.E.A. cost estimates.

Your approval is requested so that lights can be ordered and installed before freeze-up.
