

SUBJECT: 1993 Liquor License Renewals

In accordance with Council Policy Statement No. 88-5, the Clerk's Office began its review of liquor establishments within Wasilla. Because the Clerk's Office began its review process later than usual, we ask Council to give those establishments with violations 30 days to rectify the problems before letters of protest are filed with the Alcoholic Beverage Control Board.

There are 20 liquor licenses within the City of Wasilla, 19 of which are currently operating. Amvets Post #9 anticipates becoming operational during 1993. There are 5 currently listed on the attached form with at least 1 violation.
