Appointment of Irl T. Stambaugh as Wasilla Chief of Police

Council is respectfully requested to confirm the Mayor's selection of Mr. Irl T. Stambaugh as Chief of Police.

Mr. Stambaugh was selected from the three top candidates recommended by the Police Chief Advisory Committee. The Mayor conducted meetings with the three candidates, including a one-hour face-to-face interview, an hour-long tour of the City with Deputy Administrator Bob Harris, written response to questions on organizational tasks for the new department and domestic violence procedures and a half hour follow-up interview.

fter reviewing the resumes, submittals and references and considering the interest, local knowledge, experience, recommendations and style of communication of each finalist, the Mayor has chosen Mr. Stambaugh for the following reasons:

Mr. Stambaugh's experience, education and training substantially met the requirements of the recruitment notice.

Professional and personal references speak strongly of Mr. Stambaugh's competence, character and public relations skills.

Mr. Stambaugh demonstrated a good understanding of Wasilla's economy, climate and social culture.

The experience and technical knowledge gained from his 22 years with Anchorage's large metropolitan police force, lately as captain of their patrol division, will translate positively to nearby Wasilla.

The applicant has demonstrated considerable attention to the details and politics of developing an effective new police department in Wasilla.

Mr. Stambaugh communicates directly, clearly and in a well-organized, professional manner and relates well to be Mayor and Deputy Administrator.

Further, Mr. Stambaugh understands the risks involved by accepting the job in light of pending sales tax litigation and the October 1993 mayoral election. Mr. Stambaugh's salary requirements have not yet been negotiated but are within the \$42,000 to \$62,000 range offered in the recruitment notice. A formal offer of employment is contingent on Council confirmation. Employment is further conditioned on a successful background check and mandatory drug test.

I ask for your confirmation of Mr. Stambaugh as Chief of Police.

Dear Mayor Stein:

Thank you for the opportunity to comment upon Mr. Stambaugh's candidacy for appointment to the Chief's job with the newly formed Wasilla Police Department. I have worked with Captain Stambaugh since the fall of 1974 when I joined the Anchorage District Attorney's Office, so I hope my comments are helpful to you and the other members of the selection committee.

In my almost nineteen years of work as a prosecutor, I have learned that for any police department to be successful and held in high esteem by the public it serves, it must first be successful in getting the community behind it and involved in the process of policing themselves. There has to be a real commitment by the officers, and especially the Chief of Police, to work with the community, rather than on the community. That philosophy will be especially important in Wasilla where there are many who are less than enthusiastic about the formation of your new police department.

The new Chief of Police will be under continuous scrutiny for the foreseeable future, not only to provide top notch police services but to take a hands-on approach in building a police department from the ground up -- including everything from training and equipping his officers to making sure they professionally discharge their sworn duty to serve and to protect.

I sincerely believe that of the three finalists for that position, the most qualified is Captain Stambaugh, an Alaskan who is a 22 year police veteran with the Anchorage Police Department,

Alaska's largest municipal police agency serving a constituency which in many ways resembles that of Wasilla.

As you know from his resume and your personal interviews, he is an officer who has worked up through police ranks first as a Patrolman, Sergeant, Investigator, and later as Lieutenant, Captain of APD's Technical Services Division and now as Captain in charge of APD's large Patrol Division. As an administrator, he has shared responsibility for an almost fifteen million dollar departmental budget.

Over the years, I have worked professionally with Captain Stambaugh on many criminal cases which, from time-to-time, have involved contact with the media and community organizations on sensitive cases. Across the board, he has distinguished himself as a bright, hard working and honest cop who is very well respected by his peers, the attorneys in my office, members of the criminal defense bar, the bench and the public.

These days citizens rightfully expect officers to be assertive in time of danger, restrained in potentially explosive situations, and legally correct in their judgments.
