

Subject: Whispering Woods Paving

Administration has received the attached request from resident owners of property adjacent to Whispering Woods Drive and within the city boundary. We have noted an increase of traffic on Whispering Woods as the Parks Highway traffic has made it more difficult to enter and exit at Seward Meridian and at other locations. The construction of WalMart may further add to the traffic on Whispering Woods Drive.

We have been informed that the signers of the attached letter are aware of the City policy on Local Improvement Districts. An accurate engineered cost estimate for the project is expected to cost about \$5,000 because of significant construction challenges. If approved, we plan to pave the portion of the street within the city boundary to residential street standards.

Request council authority to proceed with obtaining the project cost estimate with funds appropriated in Ordinance No. 93-17 (\$100,000) for road improvements.
