Subject: Fees at Wasilla Airport

Recently the Council approved a reduction in the airport property lease from \$.10 per square foot to \$.06 per square foot. The reduction in rate resulted in the lease of one lot and interest by other potential tenants.

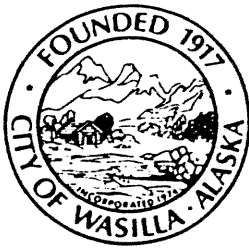
We have about 40 aircraft permitted for tie down. There are about 40 more spaces that can be assigned as pull-through parking spaces. To date, there has not been enough aircraft tied down to warrant anyone using a "tail-in" parking place. Therefore, since there hasn't been any difference in the use of a designated "tail-in" space and a "pull-through" space, all permit holders have been charged \$25.00 per month.

We do not believe that under the circumstances we could properly charge anyone \$40.00 for a pull-through space when, in effect, the \$25.00 spaces are also pull-through.

Resolution No. WR 91-24 sets the fee schedule for the airport. Recommend that Council approve Resolution No. WR 93-28 reflecting a standard \$25.00 per month for any tie-down space rental on a first-come, first-choice basis.

RESOLUTION NO. WR91-24

A RESOLUTION OF THE CITY COUNCIL OF WASILLA, ALASKA PERTAINING TO THE WASILLA MUNICIPAL AIRPORT.

WHEREAS, the Wasilla City Council wishes to maximize revenues to offset maintenance costs at the Wasilla Municipal Airport; and

WHEREAS, Wasilla Ordinance Serial No. 91-01 provides that fees for services and activities at the airport shall be established by Council resolution.

NOW, THEREFORE BE IT RESOLVED that the following fee schedule for services and activities at the Wasilla Municipal Airport are set as follows:

(1) Daily Transient Aircraft Parking:

0 - 6 Hours	No charge
6 - 24 Hours	\$ 2.00
24 - 72 Hours	\$10.00

(2) Tie-down Space Fees:

Tail-end Space	\$25.00 per month
Pull-Through Space	\$40.00 per month

(3) Impoundment

Basic Fee	\$40.00
Storage Fee	\$ 6.00 per day

(4) Motor Vehicle Parking

0 - 24 Hours	No charge
2 or More Days	\$ 2.00 per day


(5) Land Lease Rate 10¢ per square foot per year
