Borough Audit of Parks Budget

During calendar years of 1991, 1992 and the first half of 1993, the City received funds from the Borough to maintain the parks. Some of the planned improvements were not purchased and in some cases we underspent the budget we submitted to the Borough. A recent audit identified some \$13,000 of funds received by the City but not spent in the parks activities.

We identified several improvements needed in the parks and the Borough has granted permission to commit the \$13,000 for those improvements. The funds have lapsed into the City general fund and need to be appropriated to the City capital improvement fund and then expended for the approved purposes.

Recommend introduction and adoption of the attached appropriation ordinance.
