Whispering Woods - Lot 3A, Block 3, Mt. Village

The Mat-Su Borough is proposing a paving special assessment district for the Whispering Woods Subdivision adjoining Wasilla city limits. By CM 93-76, Council has earlier authorized the City funding to complete paving on Hermon Road within the City at a cost of \$7,500.

Vasilla holds a Clerk's Deed on Lot 3A, Block 3, Mt. Village because of an L.I.D. tax foreclosure (Alsop). We have received notice that Lot 3A will be assessed \$5,722.22 if the paving district is approved. Since the paving costs are consistent with our recent experience, the paving will increase the value of the lot and road paving has been a high priority with the City we respectfully ask Council to:

- (1) Support the Borough paving assessment of \$5,722.22 against Lot 3A, Block 3, Mt. Village; and
- (2) Approve the use of \$5,722.22 from \$100,000 in funds appropriated by Ordinance 93-17 for road improvements (paving and repair).

Costs for Lot 3A paving can be recovered through eventual sale or repurchase.

The Matanuska-Susitna Borough real property records show you as the record owner of the property shown on the exhibit enclosed.

The Assembly of the Matanuska-Susitna Borough will hold a public hearing on April 19, 1994 at 7:30 p.m. in the borough assembly chambers, located at 350 East Dahlia, Palmer, Alaska, on a resolution for Whispering Woods Local Improvement District. The purpose of the public hearing on the resolution is to determine whether to create the road improvement district, approve the improvement plan, authorize the manager to proceed with the improvement and the total cost of the improvement against the benefitted property creating a lien on the property assessed. It is estimated that the total cost of the road improvement, including administrative and financing costs other than interest will be \$257,500. Based on the cost estimate, the assessment against each of the above listed properties will be \$5,722.22. The actual cost to be assessed will be determined upon completion of construction.


The assembly may proceed with the improvement unless owners of properties within the district bearing at least one-half of the estimated total costs of the improvement, file <u>written</u> objections with the borough clerk prior to 5 p.m. on April 15, 1994.



The attached correspondence was received on August 19, 1993. The request is to include 2 lots that are in the City into a proposed paving district to be formed by the Borough. Administration requests authority to take the following actions:

- (a) Grant permission to the Mat-Su Borough to include Lots 2A and 3A in the proposed Borough paving LID.
- (b) Inform the Borough that if the proposed paving LID is approved, the Borough will be reimbursed by the City for paving the City's portion of Hermon Road up to the boundary to connect the Borough's project. The cost is expected to be in the range of \$7,500. Funds from the \$100,000 road project ordinance approved by Council are available for this project.





AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING THE FY-93 BUDGET BY APPROPRIATING FUNDS FOR CAPITAL PROJECTS.
