Council concurrence with these appointments is respectfully requested.

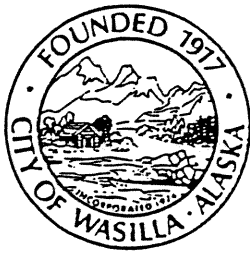
