Wasilla Planning Commission recommendation to the City Council regarding the

Matanuska-Susitna Borough six (6) year Capital Improvements Program (CIP) FY1996-

2001.

BACKGROUND

The Commission first received the Borough's request for input to the above referenced CIP at the June 14, 1994 regular meeting. At that time, the Commission scheduled a work session for July 19, 1994. At the work session the Commission discussed a number of new and existing projects that are relevant to the Wasilla community. The Commission ranked a short list of projects that were felt by the Commission to represent the highest priorities.

At the regular Commission meeting of July 26, 1994, the Commission amended and adopted resolutions 94-11 and 94-12 recommending a list of projects to the Wasilla City Council. The Commission also recommended that the City Council hold a public hearing on this list prior to sending it to the Mat-Su Borough to ensure that it truly reflects the priorities of the Wasilla community.

Draft resolutions WR94-43 and WR94-44 have been included with the packet for the purposes of discussion and to provide a basis for Council action. A suggested motion is also included, consistent with the recomendation of the Wasilla Planning Commission.

RECOMMENDATION

The Wasilla Planning Commission recommends that the City Council set resolutions WR94-43 and WR94-44 for public hearing at the next regular Council meeting in order to obtain public comment on the proposed capital projects ranked on those lists prior to submitting them to the Mat-Su Borough.

APPROPRIATE MOTION

Should the Council agree with the Commission recommendation, the following motion is appropriate:

Move to postpone action on resolutions WR94-43 and WR94-44 until the next regular City Council meeting on August 22, 1994 and schedule these resolutions for a public hearing at that time.

WHEREAS, the Matanuska-Susitna Borough exercises areawide powers within and around the City of Wasilla; and

WHEREAS, the property owners in the greater Wasilla area account for nearly half of all taxable land and improvements in the Mat-Su Borough by value; and

WHEREAS, the Mat-Su Borough, both directly and through service areas, plans, designs, contracts for construction and maintains important public roads and public facilities serving the Wasilla area; and

WHEREAS, the Wasilla Planning Commission wishes to recommend local community priorities for needed capital improvement projects involving Borough roads and public facilities which support the greater Wasilla community; and

WHEREAS, the Wasilla Planning Commission held a public worksession on July 19, 1994 to discuss and rank new and existing capital improvement project priorities for the City of Wasilla; and

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla Planning Commission of the City of Wasilla, hereby recommends that the Wasilla City Council hereby establish the following projects as City priorities for inclusion in the Matanuska-Susitna Borough's six (6) year Capital Improvement Program (CIP):

- Lake Lucille Park Access Road Improvements
- 2. Peck Street paving and extension to Fishhook Road
- 3. Seward Meridian Road upgrade, Parks Highway to Bogard Road
- 4. Seward Meridian Road extension from Bogard Road to Seldon Road
- 5. Seldon Road extension east to Bogard Road (Bogard Road extension)
- 6. Endeavor Street upgrade access to Lake Lucille Park
- 7. Vine Road/Hollywood Road paving

WHEREAS, the greater Wasilla area is served by State of Alaska maintained highways and roads including the Parks, Knik-Goose Bay, Palmer-Wasilla, Main Street/Wasilla-Fishhook, Crusey, Church, Old Matanuska and Lucus; and

WHEREAS, the State of Alaska administers the federal airport improvement program for the new Wasilla Airport; and

WHEREAS, the Wasilla Planning Commission wishes to recommend local community priorities for needed capital improvement projects involving these highways, roads and airport; and

WHEREAS, the Wasilla Planning Commission held a public worksession on July 19, 1994 to discuss and rank new and existing capital improvement project priorities for the City of Wasilla;

NOW, THEREFORE, BE IT RESOLVED, that the Wasilla Planning Commission of the City of Wasilla, hereby recommends that the Wasilla City Council hereby establish the following Alaska state capital projects as City priorities for inclusion in the Matanuska-Susitna Borough's six (6) year Capital Improvement Program (CIP):

State of Alaska - Federal Core Highway Program

- 1. Parks Highway Upgrade Glen Highway to Main Street Wasilla
- 2. Parks Highway Turnout Lanes Seward Meridian and Palmer-Wasilla Intersections

State of Alaska - Federal Secondary Highway Program

- 1. Fishhook-Main-Knik-Goose Bay upgrade and overcrossing
- 2. Church Road upgrade and paving
- 3. Palmer-Wasilla Highway extension to Knik-GooseBay Road
- 4. Old Mat Road upgrade and paving
- 5. Pedestrian/bike trails, Bogard Road, Palmer-Wasilla Highway and Lucus Road

- 1. Airport fencing
- 2. Airport runway paving
