The polls opened at 7:00 a.m. and closed promptly at 8:00 p.m. After the polls closed the administrative part of the election process was carried out. After delivering questioned ballots to the City Clerk, Precinct 38 Chairman, Mrs. Hulke holding the ballots was escorted to the Matanuska-Susitna Borough Counting Center by Chief Stambaugh, with Precinct 37 Chairman, Mrs. Fenner following in her car.

Once again the processing of voters and the administrative function when much smoother with the additional judges added for each precinct.
