Sales Tax Penalties

In August a business complained that it was assessed the sales tax return 5% late penalty after it was only one day late. I responded that we were unable to make an adjustment because of the City code but that I would review the penalty policy in general and report to the Council. If adjustments to the code seemed appropriate we would then change the rule for the benefit of all.

Dean Baugh has reviewed the penalty collections since the new rule went into effect January 1, 1994. In the past ten months, 394 penalties have been assessed against 204 businesses totalling \$8,249.51. The attached memo with a chart indicates that the penalty has had the desired effect by encouraging on-time payments.

Staff recommends no change at this time.

2. Complaints:

We have received very few complaints from business, (just like other businesses, if you are late paying your bills you pay the penalty, it is a cost of doing business) the few complaints we've had dealt with confusion as to when the penalty was applied (we rewrote the sales tax forms to try and eliminate the confusion). The other complaint was the one that raised the question.

3. Recommendations:

The penalty procedures have been in place for less then a year now (Jan 1994). The penalty appears to be doing what it was designed to do, get businesses to file their returns on time. Recommend no changes to the ordinance at this time.
