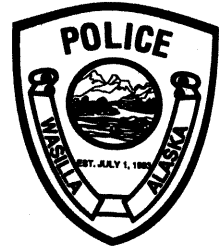

ORDINANCE SERIAL NO. 94-52

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING THE FY-95 BUDGET BY APPROPRIATING FUNDS TO THE GENERAL FUND.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

SECTION I. Classification. This is a non code ordinance.

SECTION II. Purpose. To appropriate additional funds to the FY-95 general fund for the purchase of police radars and video equipment as outlined in the attached grant documents.

SECTION III. Appropriation. Funds are appropriated to the following fund:

Fund 01- General Fund

Police Department #014213402 \$20,770.00

SECTION IV. Source of Funds.

Funds will be reimbursed per State of Alaska highway safety planning agency, grant # PT 95-04-11 B in the amount of \$20,770.00.

SECTION V. Effective Date. This ordinance becomes effective upon adoption by the Wasilla City Council.
