The polls opened at 7:00 a.m. and closed promptly at 8:00 p.m. After the polls closed the administrative part of the election process was carried out. After delivering questioned ballots to the City Clerk, Precinct 37 Chairman, Mrs. Fenner, and Precinct 38 Chairman, Mrs. Urban were escorted to the Matanuska-Susitna Borough Counting Center by Investigator Achee.

Once again the processing of voters and the administrative function went much smoother with the additional judges added for each precinct.
