Subject: Bid Report and Recommendation for FY97 Solid Waste Disposal Services

The City received two sealed bids for providing Solid Waste Disposal Services for Fiscal Year 1997. Both bids were timely and in the proper format; therefore, they were opened and read aloud as prescribed in the Bid documents.

The first Bid was from Valley Refuse, Inc. in the amount of \$18,629.40. The following irregularities were noted:

1. The Bid was qualified and an alternate bid was offered for one of the required services. The Bidder did supply a letter of explanation; however, the issue in question was grave enough and of enough consequence that the Bidder should have requested an addendum.

2. The Bidder failed to Bond the Bid as required by numerous sites in the bid package. They further certified that they had bonded the bid when they signed and submitted the Bid Form.

While item one is highly questionable, there was no action taken as a result of this irregularity. Item two is a major flaw and can not be forgiven. Failure to Bond the Bid is cause for rejection and the bid was rejected.

The second Bid was from Wasilla Refuse, Inc. In the amount of \$14,003.04. There were no irregularities noted with this bid.

A through review of the Bids indicates that Wasilla Refuse, Inc. Was the only responsive Bidder and delivered the lowest bid.

RECOMMENDATION:

The Public Works Department recommends that the Council declare Wasilla Refuse as the lowest responsive Bidder for the FY 97 Solid Waste Disposal Services and authorize the Administration to enter into a contract for these services for \$14,003.04.
